He observed Some miscreants trying to exfiltrate into BD side near BFL no 16 by damaging the IBBF. Sentry immediately challenged them and fired one round of PAG(Butt no -43 Body no- 25PG00363 Rds-01 No Lot no -KF/02/25/02/001). Due to swift action of sentry appx. 3 to 4 miscreants ran back towards India side taking advantage of thick fog , vegetation and undulating ground and 4 to 5 person crossed into BD territory. about 0341 hrs No-213311715 CT Kanchan chauhan C2C sentry also observed the movement of 4 to 5 miscreants going towards BD side in camera no D-8 at BFL no- 16 and informed the spot sentry
