Sir,

I, Dipankar Ghosh, son of Narayan Ghosh, resident of Chayan Para, Ghoghomali, Ward No. 37, Siliguri, lodged this complaint with the information that on 16/01/2026, at approximately 00:30 AM, my maternal uncle, Premananda Ghosh (S/o Mani Ghosh, resident of Ghoshpara Tarakali More, Mangalbari, Maldah), was driving a truck (Registration No. WB59B2111) loaded with stones toward Kishangani upon reaching the Jatiakhali Main Road, my uncle's vehicle collided with another truck (Registration No. CG15AC3118). The said truck (CG15AC3118) was parked Hazardously on the road without any precautionary measures, reflectors, or parking signals, making it a death trap for other commuters in the dark. Following the collision, my uncle and his assistant/Khalasi namely Jamat Khan, sustained injuries. They were rescued by local residents and rushed to North Bengal Medical College & Hospital (NBMC&H), tragically the attending doctors declared my uncle dead and the Khalasi was medically treated there he received minor injuries in this incident.

The Post Mortem of my uncle has been conducted under Matigara PS U/D Case No. 74/2026, dated 16/01/2026.

The accident was caused solely due to the gross negligence and illegal parking of the offending truck (CG15AC3118) by its driver.

I, therefore, request you to kindly register an FIR against the driver of the offending

Hence I am requesting you please take a legal action against the offending truck driver as per Law.
