I, Sri Manik Das, (45), Assistant Engineer (Electrical) & Station Manager, NJP Gate Bazar C.C.C, WBSEDCL, (S/O: Sri Akshay Das), do hereby lodge complaint against aforesaid Smt. Renuka Bhowmick to the effect that, on 19.01.2026 in course of inspection, myself along with (1) Shri Bijay Lakra, S/O: Bernard Lakra, Superintending Engineer & (2) Shri Bhaben Roy, S/O: Late N.C Roy, SO, both are from Darjeeling Regional office (S & LP wing), WBSEDCL, (3) Shri Sukanta Talukder, Sr. Office Executive, S/O- Late Santosh Talukder, (4) Shri Subhankar Neogi, Linesman, S/O: Late Swapan Kumar Neogi of NJP Gate Bazar CCC & other technical staff of NJP Gate Bazar CCC had been to the premises of Renuka Bhowmick, W/O: Late Jaharlal Bhowmick of of Surya Sen Colony, Block-C, Ward No-34, P.S. NJP, Dist: Jalpaiguri at 13.49 Hrs. Prior entry to the premises, a notice was issued in the name of Smt. Renuka Bhowmick for inspection of the said premises which was received by Renuka Bhowmick, the consumer. I arrange to call witnesses from the vicinity but none turned up. However, in presence of the consumer of the said premises we conducted inspection.

During inspection it was found that, there has one Industrial connection vide consumer id: 400735779 in the name of Renuka Bhowmick in the premises from which he has made unauthorized extension of line to other premises, where there has a disconnected service line vide consumer number 412082525 in the name of her deceased husband named Jaharlal Bhowmick, having outstanding due amount Rs. 8415.00. Due to this unauthorized use of electricity WBSEDCL has occur a loss of revenue. On detection of such illegal use of electricity service line i.r.o consumer id: 4007335779 was disconnected & meter i.r.o consumer number 412082525 was dismantled. During inspection load of electricity consumption as observed in the same premises was 1.23 KW. On being asked, Renuka Bhowmick admitted his guilt for committing aforesaid offence. Thus it has well been established that, aforesaid Renuka Bhowmick, W/O: Late Jaharlal Bhowmick of of Surya Sen Colony, Block-C, Ward No-34, P.S. NJP, Dist: Jalpaiguri has committed offence for which he is liable for prosecution U/S 135(1) (e) of The Electricity Act' 2003 amended in 2007.

Inspection report was prepared. I seized the following article under proper seizure list on 19.01.2026 from 14.00 hrs. to 14.20 hrs at the same premises in presence of the consumer.

1. Single core, 2.5 Sq mm copper wire, Approx. length: 4 meter.
