Jalpaiguri, Uncle - in-law Arup Kumar Das Son of Late Amulya Kumar Das resident of Dishira, P.O. Peor, P.S. Hill, Dist- Dakshindinajpur.

Respected Sir,

I, **SMT. CHHABI PAUL** Wife of Sri Prasenjit Paul, residing at Bhaktinagar, Ward No. 35, Dist. Jalpaiguri, do hereby lodge a complaint against my husband prasenjit Paul, Son of Dilip Paul and mother-in-law Pali Paul Wife of Dilip Paul, Uncel-in-law Arup Kumar Das to the effect as follows :-

- 1) That my marriage was solemnized in the year of, 2015 with said Prasenjit Paul as per Hindu Rites and Customs.
- 2) That after the said marriage, I was living together as husband and wife at my above mentioned matrimonial home.
- 3) That out of the said Wedlock, two female baby namely Nandini Paul was born in the year, 2016 and Nabanita Paul in the year 2022.
- 4) That since the marriage my mother-in-law and my husband on the instigation and abetment and abetment of my Uncle-in-laws my husband paternal home, I convey to my parents but my parents could not fulfill his demand as they are very poor and could not afford it .
- 5) That as my parents were unable to fulfill his illegal demands, he started physical and mental torture upon me day after day.
- 6) That after the birth of younger daughter the physical and mental torture had been increased and my uncle-in-law used to come matrimonial home and my uncle-in-law used to come to matrimonial home and offered me to cohabit with him and told me if I told anyone these things he will kill me husband and in-laws physically assaulted me mercilessly and drove me out of the matrimonial house and due to which I have been living separately in a rented house.
- 7) That my said husband has use to come at rental house in an intoxicated state at late night he physically assaulted me with slaps and thorottled my neck and when I Was gasping/suffocating then he left my neck and started abusing me in most obscene languages and use to assault me physically but did not provide me food and colthing: Since birth of my younger daughter, my husband did not maintained properly and sufficiently to me and my younger.

-) That in the month of December, 2024 my husband took my elder daughter without my knowledge.
-) That my husband always threatened me if I will not go to house of my uncle-in-laws Said Arup Kumar Das he will divorced me and did not maintain me.
- 0) That it is further inform that my husband along with my in-laws has been regular giving threatening of dire consequences if I lodge any complaint against them over the said matter with the police or before the Court and giving me mental harassment and agony over mobile phones.
- 1) That I went to the NJP P.S. To lodge the complaint against the aforesaid persons over the reason best known to them.

So, therefore, I humbly request your good self to take necessary legal action against my husband and in laws at an earliest.
