Subject: Application for registration of FIR against my husband and in-laws for domestic violence, dowry harassment, criminal intimidation, illegal CCTV surveillance, assault and forcible removal of my minor child.

Respected Sir/Madam,

I, SMT. HEMA GURUNG, wife of Mr. Subhash Tamang, resident of Rupnarayan Singh Nagar, Tumbajote, Matigara, Siliguri, near Lachamaya Apartment; near West Point School, PIN-734010, humbly submit this application seeking registration of an FIR against my husband and his family members for continuous physical, mental and emotional cruelty.

Details of Accused Persons

1. Mr. Subhash Tamang – Husband
2. Mother-in-law (Saas)
3. Sister-in-law (Nanad)
4. Brother-in-law (Nandoi/Jija)

(All residents of the matrimonial home)

Facts of the Case

1. I was legally married to Mr. Subhash Tamang and we have a minor son aged about 1½ years.
2. Since marriage, my husband and in-laws have been continuously harassing me for dowry, mentally and physically torturing me and treating me like a servant in the house.
3. My husband frequently assaults me, raises his hands on me and abuses me in filthy language. My mother-in-law, sister-in-law and brother-in-law actively support and instigate him.
4. My husband often threatens me and my parental family, and has openly stated that he will marry another woman. He also abuses my parents with vulgar language.
5. Though my husband gives some money occasionally, he does not take responsibility of me or our child and behaves like an unmarried man, not like a married husband or father.

6. On recently, my minor child was suffering from fever, throat infection and measles. The doctor clearly advised 7 days of isolation. Only 5 days had passed when my husband forcefully pressured me to go for a picnic with the child.
7. When I refused for my child's health and requested to go after medical isolation, my husband became violent. He snatched my mobile phone, beat me in front of my mother-in-law, and attempted to strangle me by pressing my neck, while threatening to kill me.
I also have audio recordings of threats.
8. My husband openly threatened me saying that in Nepali culture a wife can be killed, which caused extreme fear and mental trauma.
9. Thereafter, my husband along with my mother-in-law forcibly took away my minor child and went to Nepal, without my consent, endangering the life and health of my child.
10. I further state that my husband illegally installed a CCTV camera inside our bedroom without my consent, which is a gross violation of my privacy and dignity. The camera was used to monitor and mentally harass me, causing severe humiliation and trauma.
11. Due to continuous violence, threats, illegal surveillance and fear for my life and my child's safety, I am living under extreme mental stress and insecurity.

PRAYER

In view of the above facts, I humbly request you to kindly:

1. Register an FIR immediately under appropriate sections of law against my husband and in-laws.
2. Take strict legal action against the accused persons for domestic violence, dowry harassment, assault, criminal intimidation, illegal CCTV surveillance and child endangerment.
3. Ensure urgent recovery, safety and medical welfare of my minor child.
4. Provide immediate police protection to me, as my life is under constant threat.
5. Seize and investigate the illegally installed CCTV camera and recordings.

I shall be ever grateful for your kind cooperation.
