I, Sri Tapas Bishui, Divisional Engineer (E) & Station Manager, Hakimpara CCC, WBSEDCL, Siliguri do here by lodge complaint against Dhanraj thakur (Present user, Ph No-8509894075), S/O- Lt. Bejanath thakur, M/S Scissors & Combs, Aargee Lodge, Bidhan Road. Ward no-11, Siliguri, Dist-Darjeeling, Pin-734001 for having committed offence as stated here under.

On 21.01.2026 at about 02:05 PM. acting on a source information I, along with 1) Sri Tapas Bishui, Divisional Engineer (E) & Station Manager, Hakimpara CCC, WBSEDCL, 2) Sri Bhaben Roy, S.O., S&LP Wing, Darjeeling Region, WBSEDCL, 3) Sri Biswajit Ghosh, Linesman, Hakimpara CCC and other officials of WBSEDCL entered the commercial premises of Aswini Kr. Ghosh and inspected service installation, metering installation of Consumer ID 412112921 in the name of Aswini Kr. Ghosh. During inspection it was found that Dhanraj thakur (Present user) is using electricity unauthorisedly & illegally by reconnecting the disconnected service line of the metering installation that was disconnected previously on 06.01.2026 due to non-payment of outstanding energy bill. Total Outstanding dues Rs. 19224.00 (Rupees Nineteen thousand two hundred and twenty-four only) including the LPSC of Rs. 207.00 (Rupees two hundred and seven only) till the date.

As unauthorised reconnection of the disconnected service line and metering installation was detected, the energy meter, make Landis & Gyr Ltd, serial no.- L3305256 installed against Con Id. 412112921, seized by preparing a formal seizure list duly signed by witnesses.

As Dhanraj thakur (Present user) have committed offence u/s 138(1)(b) of Electricity Act 2003 by using electricity illegally & unauthorisedly by reconnecting the disconnected service line, you are requested to take cognizance of the same by treating this complaint as FIR. The seized articles are packed and labelled by me.
