Sir,

I, SI Arun Roy (30 years), son of Bhim Chandra Roy, posted at Cyber Crime PS, Siliguri Police Commissionerate, hereby lodge a written complaint stating that today, on 21.01.2026 at approximately 12:15 hrs, while engaged in social media monitoring duty at Cyber Crime PS, Siliguri, I came across a Facebook user named Puja Mahato (profile link: <https://www.facebook.com/puja.mahato.245929>). She had posted communal and provocative video comments with the subject "अगर बंगाल में चाहिए शांति तो करनी पड़ेगी क्रांति" on 23.12.2025, which have gone viral with about 21.1K views. The link to the video comments is <https://www.facebook.com/share/r/1G61rP3SBk/>.

The circulation of such inflammatory content on social media amounts to abetment of communal violence and has the potential to incite unrest among communities within the jurisdiction of Siliguri and its surrounding areas.

The user, Puja Mahato, daughter of Late Jamin Mahato, residing at Tulsi Nagar, Kholabaktari, PS Matigara, has previously uploaded similar provocative content. A case was registered against her under Cyber Crime PS Case No. 106/25 dated 25.09.2025, under Sections 196(1a)/(1b), 353(2), and 299 of the Bharatiya Nyaya Sanhita (BNS). She is currently out on anticipatory bail granted by the Vacation Judge, Siliguri, with a directive not to enter the residential jurisdiction of Tulsi Nagar.

Her continued posting of communal and provocative video comments may expose her to retaliatory actions, which could cause serious communal tension between two religious groups in her locality. An incident of communal violence had already taken place at Kholabaktari and Tulsi Nagar on 18.01.2025, and timely police intervention along with the introduction of a police picket was implemented as a preventive measure to avert a breach of peace. Accordingly, a specific case has been lodged at Matigara PS vide Matigara PS Case No. 36/26 Date 19.01.2026 U/S- 132/121(1)(2)/3(5)/189(2) BNS.

Under the above circumstances, I request that an FIR be registered against the Facebook user, Puja Mahato, daughter of Jamin Mahato, residing at Tulsi Nagar, Kholabaktari, PS Matigara, under the appropriate sections of law.
