Respected Sir/ Madam,

I, Rina Ghosh nee Das, Wife of Sri Tuku Das, Daughter of Late Rabin Ghosh, presently residing at Suravi Apartment, Ward No. 15, Raja Rammohan Roy Road, Hakimpura, Post Office & Police Station- Siliguri, Dist. Darjeeling, Pin: 734001 do hereby lodge this written complaint against my husband Sri Tuku Das, Son of Sri Holodhar Das, resident of Jamuri Bhita, Fulbari 1, P.O-Sahudandi Haat, P.S-N.J.P, District-Jalpaiguri and against Smt Ruma Ghosh, Wife of Sri Tuku Das, residing at the same address as of Sri Tuku Das stating that I was married to my husband Sri Tuku Das on 30.07.2009 at Siddheshwari Kali Mandir, Jalpai More, P.O & P.S- Siliguri, Dist- Darjeeling, soon after our marriage, my husband started torturing me physically and mentally as he was a habitual drunkard and used to come home in an intoxicated condition under the influence of alcohol, at that relevant time we used to stay near fuleshwari pipeline in a rented premises.

Thereafter on 11.02.2012 out of my and my husband's wedlock a male child was born namely "Tridip Das" at N.B.M.C.H.

I expected that after the birth of the child the temperament of my husband will change and we will lead a normal life but as his responsibility increased he became more violent and he started beating me with belt and on one occasion he did break my nose and caused nasal fracture.

On 20.06.2022 my husband drove me away from my matrimonial house and later I came to know that he had an illicit relationship with my elder sister Smt. Ruma Ghosh and after driving me and my minor son out of the house he married my elder sister Smt Ruma Ghosh during the subsistence of our lawful marriage and at present they live together at Panchkelguri.

I and my husband are living separately since 20.06.2022 but <sup>on (12/1/2026) Rina Ghosh</sup> ~~yesterday~~ all of a sudden I saw him at Bidhan Market at about 09:00 p.m and he came to me and abused me in slang and filthiest language and slapped me three times.

Under the above circumstances I request you to kindly take the necessary action and investigate the aforesaid matter against the above named miscreants for treating me with physical and mental cruelty, marrying again during subsistence of previous marriage and for slapping me.
