Respected Sir,

I, Julekha Khatun, Wife of Md. Rustam, at present resided at Hemanta Basu Colony, Ward No. 04 of S.M.C., P.O. & P.S. Siliguri, Dist. Darjeeling, beg to report you the following facts:-

1. That 8 years ago my marriage was solemnized with my husband namely Md. Rustam, and soon after marriage I started to live with my husband at his house at Jyoti Nagar, Ward No. 04, S.M.C., P.O. & P.S. Siliguri, Dist. Darjeeling, and out of our wedlock relation we blessed two child (i) Md. Parvej of 7 years, (ii) Md. Danish, of 3 years.
2. That soon after marriage my husband and his relatives (in-laws) namely Papa namely Ishaque Miya and his two sisters namely Sehnaz Khatun, Sabana khatun and his brother Md. Rizwan started inflicting torture upon me both mentally and physically, every day without any reason my husband and his relatives abuses me, on my any small request for having food they became furious and started abuses me in filthy and offensive languages. They compelled me to live in their house like house maid and forced me to do all house hold work like their servant. They use to provide me a very small quantity of food, they never allow me to take food from the kitchen to myself. On numerous occasions I have to work whole day at my in-laws house without eating anything, resulted several times I became ill but my husband and his parents never allow me to go outside or to take medicine to myself. But their torture and work load of their house never decrease and I have to complete all their house hold work in my ailing conditions. My husband and in-laws treated me like animal. My husband and his two sisters forcefully kept all my ornaments / jewelleryes. Later I knew that my husband has an illicit relation with another girl namely Priyanka Das. My husband several times assaulted me brutally whenever I asked about his such illicit relation. And last in the month of January 2024 my husband secretly took my all ornaments fled away taking said girl beyond my knowledge, leaving me and my minor children in a rented house.
3. That since 4 – 5 months my husband returned in Siliguri and now a days he resided with his newly married-wife at Tulshi Nagar, Natunpara, under Matigara Police Station, Dist. Darjeeling.

That on getting such information on 14.01.2026 at about 2 p.m. I went at newly resident of my husband's house at Natun Para, Jalpai more, Siliguri and asking to return my all jewellery hearing this my husband and his newly married wife Priyanka Das became furious and started assaulting me, with fists and blows and by kicks, para people gathered on the spot after hearing my hue and cry, they help me to get release from their clutch. I got multiple bodily injury on my person. Later I went at Siliguri Dist. Hospital for my treatment.
5. That my husband use to work in Hum Safar Packers & Movers agency situated at Hill Cart Road, Dagapur Math, Siliguri and he earns about 1200 – 1500 per day. But he never gave me any single farthing to me and my children.
6. That Sir, due to their such brutal assault I became ill as such I could not lodge the F.I.R. in due time which kindly may condone.

I, therefore, request you to kindly take necessary legal action against the above mentioned persons i.e Md. Rustam my husband, his newly married wife Priyanka Das, Ishaque Miya his father and his two sisters namely Sehnaz Khatun, Sabana khatun and his brother Md. Rizwan for the commission of the aforesaid offences by them upon me.
