Dear Sir,

We have one godown measuring 4 Katha 13 Chatak Plot Nos. 40/793 in Kh No. 803 & Plot No. 42/505 in Kh No. 805 located in Main road of Eastern Bye Pass, Opp. To Kay Pee Udyog & House of Ceramics, Pargana – Baikanthapur, Mouza – Dabgram, PO & PS Bhaktinagar where we used to keep some stock of Printing Cylinders of our Factory located in Plot No. 6, Siliguri Industrial Estate, Siliguri - 01.

Today (24.01.26), at around 11.50 AM when our factory driver Mr. Nikhil alongwith one staff Mr. Shiba went to put some printing cylinders in the godown, he was shocked to see that most of the godown was empty and also the gate at the backside was broken and another gate in the front also was broken. On checking the stock and the count it as observed that appx 325 Cylinders were stolen monetary value appx 16.50 Lacs. The Cylinders are made from MS and can easily be sold in any of the Scrap dealers located in the vicinity at Scrap prices. Also, its observed that the electrical wires inside the godown had been taken out.

We had lodged our complaint over call & during joint inspection with the Police officers from Bhaktinagar PS it was observed that many liquor bottles and glasses were also there in the gully apart from the broken gates & stolen goods. As, there is no CCTV in the vicinity so we aren't able to provide any. We, would henceforth request you to kindly lodge our FIR and find the culprits and help us recover our stolen materials.
