Sir,

With due respect and humble submission I, ASI Subhash Bahadur Tamang of Matigara P.S. beg to lodge this written complaint as Suomotto that I was deputed to perform Night Patrol duty along with force from 22:00 hrs on 23/01/26 to 08:00 hrs on 24/01/2026. vide Matigara PS C.C. No. 198/26 Dated 23/01/26 and GDE No- 1295 Dt- 23/01/26. During my said night patrolling van duty at around 00:30 hrs received an information from the on duty officer that one person is creating nuisance in a Saswati Puja Pandal, situated at Baniakhari near Lalpool under Matigara PS jurisdiction. Accordingly I informed the matter to I/C Matigara PS and as per his kind direction myself along with forces had been at Lalpool, Baniakhari under Matigara PS. After reaching Lalpool I came to know that a Saraswati puja was going on at Lalpool, Banikhari under Culvert. At about 00:00 hrs, puja committee members wanted to stop the music system due to late night. At that time one person namely Dambar Rai, S/O- Mani Kumar Rai of Lalpool, Baniakhari, PS- Matigara, Dist- Darjeeling trespassed at the Saraswati Puja premises in drunken condition and started restraining the Puja Committee members to stop the music system as he want to dance with the music. When the committee members tried to stop the music system, said Dambar Rai started assaulting the members of said Puja Committee. Later Dambar Rai broke the music system also damaged the Puja Pandal premises. Accused person also threatened the committee members that he will kill everyone. Later when the committee members called Police, the accused person escaped from the place.

Under the above circumstances I would like to inform you that a specific case may kindly started against the accused person namely Dambar Rai, S/O- Mani Kumar Rai of Lalpool, Baniakhari, PS- Matigara, Dist- Darjeeling under proper section of law and arrange for its investigation.
