Sir,

With due respect, I SI Mrityunjoy Roy of Matigara P.S, SPC do hereby lodge this Complaint to the effect that on 25.01.2026 at about 12:45 hrs onwards in course of K-33-I mobile van duty vide Matigara PS GDE No.1352 & M.C.C No 213, Dated- 25.01.2026, received an information that one vehicle loaded with river bed materials coming from Rananagar area without any valid documents. Accordingly, I inform the fact to inspector in charge, Matigara PS and as per his kind direction myself along with force had been to Rananagar under Matigara PS to work out the information in hand. After arrival at Chandmoni Hospital Line, PS Matigara, I found one Truck bearing Reg. No. WB-76-9785 loaded with river bed materials going towards Paticolony side. Subsequently, I manage to stop the vehicle and apprehended the driver of the vehicle. On demand he failed to produce any valid documents in respect of river bed materials loaded in his vehicle. Accordingly, I seized the vehicle bearing Reg. WB - 76-9785 under proper seizure list and also arrested the driver of the vehicle namely Bimal Barman (32) yrs. S/O Late Rakhal Barman of Rananagar Colony, PO + PS. Matigara, Dist. Darjeeling after observing all sorts of formalities .

Therefore I pray before you that a specific case may kindly be started against the driver of vehicle named Bimal Barman (32) yrs. S/O Late Rakhal Barman of Rananagar Colony, PO + PS Matigara, Dist. Darjeeling and the owner of the seized vehicle bearing Reg. No. WB 76-9785 under proper section of law and arrange for its investigation.
