Sub: Complaint regarding extortion demand of Rupees Ten Crores

Dear Sir,

I Dinesh Kumar Gupta, son of Late Deonath Prasad, resident of Tower No. 390, Upwan Apartments, Uttarayan, Matigara, P.O & P.S- Matigara, Dist- Darjeeling, beg to lodge this complaint as under:

1. I am a resident Businessman of the city of Siliguri.
2. I am with great concern, bringing to your notice that on 22.12.2025 at about 01:16 pm in the afternoon, I received a phone call over WhatsApp from a number with the country code of Malaysia being +60-1161189431, through which a person introducing himself as the brother of gangster Arzoo Bishnoi and a member of the dreaded Lawrence Bishnoi gang threatened me to pay him an amount of Rupees Ten crores, failing which he would kill me and my family. I with utmost fear tried to reason with him that he may have mistaken me for someone else as I do not have any such profile or resources to give in to such demands made by him, but he refused to relent and stuck by his threat of taking the lives of mine as well as my family. After having disconnected the call, I received an elaborate message from the said number over WhatsApp detailing the threat upon my life, which I am attaching herewith for your ready reference and perusal.
3. Days went by thereafter, and upon discussion with my family, we dismissingly ignored such call to be a prank, but on 07.01.2026, at about 7:48 pm in the evening, I received a second call, this time again from a Malaysia based number being +60-1167840868. Upon receiving the call, a foreboding sense of fear engulfed me as the voice over the phone was of the same person who had made the previous call on 22.12.2025.
4. During this call which went on for more than 7 minutes, this person, made his intentions clear that if the demanded amount of rupees ten crores is not paid to him and his gang within the next 7 days, than he would brutally kill me and my family.
5. Promptly thereafter, I received a phone call from one Shankar Sahu of Koran Sarai, District- Buxar, in the state of Bihar, who very surprisingly asked me whether I received any threat / extortion call during the past few days. This, very naturally took me by surprise as I had not mentioned or disclosed the incidences aforementioned to any person.

Moreover, a staff of mine, namely Sumit Gupta informed me that Shankar Sahu along with one Dhiraj Mishra, who is currently serving time in prison in Ramgarh, Jharkhand and their associates have possibly hatched up this conspiracy with an intent to extort money from me by putting my life into fatal threat and as such I am making this fervent and anxious request to you to trace out and bring the miscreants to justice as I and my family are living in constant fear and foreboding anxiety

Needless to mention that I shall always be available for any assistance that may be required from my end for you to effectively unearth the crime committed as stated above.
