In producing herewith following four accused persons named (i) Subham Panna, aged 25 years, s/o- Biren Panna, resident of Vistijote, PS- Bagdogra, Dist- Darjeeling, (ii) Melchoir Toppo, aged 24 years, s/o- Kishor Toppo, resident of Vistijote, PS- Bagdogra, Dist- Darjeeling, (iii) Gulsan Ekka, aged 30 years, s/o- Late David Clave Ekka, resident of Gangaram TE, Pakka Line, PS- Bagdogra, Dist- Darjeeling and (iv) Kishor Kachwa, aged 30 years, s/o- Chabilal Kachwa, resident of Vistijote, PS- Bagdogra, Dist- Darjeeling (not verified) under custody along with following seized articles:

- (i) One iron-made knife (Kalam chhuri) measuring total length 14 inches including wooden handle measuring length 6 inches and iron made body part length 8 inches seized from the possession of accused Kishor Kachwa and marked as Exhibit-A.
- (ii) One iron-made knife measuring total length 14 inches including wooden handle measuring length 6 inches and iron made body part length 8 inches seized from the possession of accused Melchoir Toppo and marked as Exhibit-B.
- (iii) One iron made rod measuring length 2 feet seized from the possession of accused Subham Panna and marked as Exhibit-C.
- (iv) One backpack styled as "WILDCRAFT" seized from the PO and marked as Exhibit-D.
- (v) One nylon rope measuring length 14 feet is recovered & seized from Exhibit-D and marked as Exhibit-E.
- (vi) One torch light is recovered & seized from Exhibit-D and marked as Exhibit-F.
- (vii) One screw driver is recovered & seized from Exhibit-D and marked as Exhibit-G.

I, ASI Munna Ahmed of Bagdogra PS, SPC, do hereby lodge this written complaint against the above noted arrested four involved accused persons and other 4/5 absconding unknown miscreants to the effect that today on 23.01.2026 at 01:45 hrs in course of performing PC night mobile van patrolling duty I received reliable source information that a group of 8/9 suspects have assembled at Singhijhora more beside AH-02 under Bagdogra PS with a preparation to commit dacoity at Stalin Nagar area. Accordingly, I informed the matter to O/C Bagdogra PS and as per direction of O/C Bagdogra PS, I formed a raiding team consisting SI Binup Mahato, ASI Amit Lama, VP/01 Anselam Kujur & CV/375 Jogesh Barman leaded by me. Then we left for Singhijhora more beside AH-02 under Bagdogra PS by Govt. vehicle No. WB61A/0137 to work out the secret source information. This refers to Bagdogra PS GDE No. 1107 dated 23.01.2026. On the way I contacted with night K-35 mobile van officer ASI Amulya Ratan Singha to accompany with us at the above noted PO. Then ASI Amulya Ratan Singha along with force C/226 Prasenjit Roy & C/384 Santosh Roy accompanied with us. At around 01:55 hrs we reached near Singhijhora more beside AH-02 and made an ambush there and waited for source indication. We parked our Govt. vehicle away from the place. After a while, source indicated us the place where the group of suspects assembled. There were a group of about 8/9 suspects at Singhijhora more beside AH-02. Then, being shown & indication by source we started to cordon them from all side. All of a sudden, some of them noticed us and tried to flee away from the spot. But after hot chase with the help of accompanying Police team we managed to apprehend four suspects there in red-handed at around 02.06 hrs. We searched for independent witnesses. Two independent witnesses named Mukesh Ray, aged 29 years, s/o- Biren Ray, resident of Singhijhora TE, PS- Bagdogra, Dist- Darjeeling (Ph. No. 7586838764) and Shibu Singh, aged 33 years, s/o- Late Tapan Singh, resident of Matigara, Tumbajote, Jora Bridge, PS- Matigara, Dist- Darjeeling (Ph. No. 7001815745) were present there. Accordingly, I arranged to search their persons in presence of the independent witness as well as the Police witnesses. On search, one iron-made knife (Kalam chhuri), one backpack, one nylon rope, one iron made knife, one iron made rod, one torch light and one screw driver were recovered from their joint possession.
