with due respect I Runu Sankar wife of Sushanta Sankar daughter of pradip Sankar at present residing at my paternal house situated at Bidyachakra Colony, Seroke Road SMC Ward No 44, Seroke Road Siliguni, District - Jalpaiguri, West Bengal, Pin Code - 734001 would like to state as follows:-

• That my marriage has been solemnized with Sushanta Sankar son of paritosh Sankar & Suryasen pally, Kadamtala, Matigara, Doojeling, on 13/12/2012 according to Hindu rites and Customs and at the time of marriage as per the demand of my husband named by Sushanta Sankar and other in-laws namely Bina Sankar (mother-in-law), Paritosh Sankar (Father-in-law), Subrata Sankar (brother-in-law) and Rimpi Sankar Dutta (sister-in-law), my father and other family members gave gold articles such as i) bangles - 2 pair (4gm each), ii) Neckless 10gm iii) earring - 4gm iv) Ring - 4gm v) gent's Ring - 4gm: Furniture such as i) Cot ii) Show case, iii) Almirah, iv) dressing table, v) sofa sofa vi) Small size almirah along with mattress, pillow and a sum of Rs 2,00,000 (Rupees

Two lakh) as dowry thereafter I started my nuptial life at my matrimonial home situated at Suryasen pally, post office: Kadamtala Police Station Matigara, Doojeling, pin code - 734011 in a joint house with my other in-laws namely Bina Sankar (mother-in-law), Paritosh Sankar (Father-in-law), Subrata Sankar (brother-in-law)

It is also pertinent to mention here that later on as per demand of my in laws and husband my father was compelled to give sofa set sofa chair, dressing table and Basin to them for the betterment of my future in my matrimonial house.

• That after our marriage, within a few days in-laws shed their false facade and showed their true colour by physically and mentally torturing me. My matrimonial family intentionally sacked the house help and compelled me to do all the house hold chores for the lust of more dowry. It is relevant to mention here that I have always been to perform the marital obligations but

ny. In laws forced me to do all the household chores, even on the days when I was sick and ailing and in order to further add to my problems my husband and in laws sacked our house help even though they had sufficient means and income to keep her.

- That it is pertinent to mention here that whenever I wanted to go to my paternal house my husband used to check my luggage as to whether I am taking anything from my matrimonial house to my paternal house which tantamount to mental cruelty. But being a traditional Indian woman, I never protested against such activities of my in laws and my husband thinking about our marriage. It is pertinent to mention here that during this time our son named by Subhonal Sarkar was born on 16/06/2014.
- That it is added further that after 2 or 3 months of my pregnancy I noticed that my husband used to mostly stay outside and when I enquired about his whereabouts he ignored me and he was also reluctant to answer my queries surprisingly to my utter shock and dismay I found that he has indulged into several extra marital relations.
- That after my pregnancy I was busy in nursing our only son and at time also my father-in-law paritosh Sarkar, Bina Sarkar (mother-in-law), Subrata Sarkar (brother-in-law) and Rimpi Datta (sister-in-law) started inflicting more torture upon me in connivance with my neighbour Tuku Sarkar, wife of Debabrata Sarkar and also asked me to bring more money from my parental house and being an Indian traditional woman I tried my heart out to save my marriage so that my son can have a happy family life but all are in vain.
- That from the middle of May 2025 my husband along with my father-in-law named paritosh Sarkar, Bina Sarkar (mother-in-law), Subrata Sarkar (brother-in-law) and Rimpi Datta Sarkar Datta (sister-in-law) along with my neighbour Tuku Sarkar, wife of Debabrata Sarkar started mental torture upon me by keeping me in starvation and also abuse me with filthy languages in trivial matters and also asked me to leave my matrimonial house and finally on 12-09-2025 the above noted persons started mental harassment upon me which reaches to the optimum level hearing this news my brother named Deep Sarkar and sister-in-law Rupa Sarkar, came to my matrimonial house and somehow rescued me and my son from the nuisance which they have created in my life from that day to up till now my husband and my in laws have abandoned me from their life.
- That my son is studying in good Shephard School at Bagdogra, in Class V and at present me and my son are residing at my parental house having no source of income and when I tried to patch up the matter, my husband flatly denied to have any kind of

relationship with me. It is also pertinent to mention here that my husband was paying the school fees of my son but now he is trying to evade such duty as well. It is pertinent to mention here that being an Indian woman I have tried reconcile and settle that matter but it was not fruitful and finding no other alternative I have come to lodge the F.I.R.

I therefore pray before you to look into this matter and take necessary legal action against that above noted persons to right of mine along with my son.
