Subject: General Diary entry regarding theft of gold and diamond ring from household premises

Respected Sir,

I, Rahul Musaddi, son of Late Rajendra Prasad Musaddi, am a resident of Vasundhara Vatika Apartment, Nimbu Basti, Siliguri, West Bengal.

I wish to bring to your notice that on 26/01/2026, I had left for Kurseong for some personal work. Before leaving, I had kept my laptop bag inside my room, which contained a small box holding a gold and diamond ring belonging to my wife, intended to be handed over to a jeweller for repair the following day.

At the time of my absence, my brother-in-law, Mr. Arjun Kumpawat who stays there, had also gone out of the house for some work. Our house help, Ms. Sonali (Mobile No.: 9749736129), came to the apartment for routine cleaning work, as she regularly does even when we are not at home. There was no suspicion at that time.

However, yesterday night, when I checked the box to take the ring to the jeweller, I was shocked to find that the box was empty and the ring was missing. Upon enquiry, we contacted the house help, Ms. Sonali, but she denied any knowledge of the missing ring. To the best of our knowledge, no other person had entered the house during the said period.

I therefore suspect that the ring has been stolen and request you to kindly record my complaint and investigate the matter, and assist me in recovering my stolen property.

I shall be highly obliged for your kind cooperation and necessary action.
