Sir,

In producing herewith one white color Tipper vehicle (Six wheeler) having display no WB-15D 1265 loaded with river bed materials along with its key under proper seizure I, PSI Wahed Kamal Pramanik of Bhorer Alo PS /SPC do hereby lodge this written complaint against the owner of the above noted seized vehicle to the effect that on 27.01.2026 at about 20.05 hours received a source information that one vehicle bearing Reg. No. WB-15D 1265 loaded with illegal river bed materials is coming through Canal Road towards Nawapara More under Bhorer Alo PS. The matter was informed to Officer In-charge of Bhorer Alo PS and as per his instruction I formed a police team and left towards Canal Road near Nawapara More to work out the information. This refers to Bhorer Alo PS GDE No- 1001, Date 27.01.2026.

At about 20.20 hours we reached at Canal Road and waited for the vehicle to arrive. After few minutes the tipper vehicle bearing Reg. No. WB-15D 1265 occupied with driver and loaded with river bed materials was proceeding towards Nawapara more. On the way I tried to stop the vehicle by showing signal to the driver of the vehicle. After seeing the police team the driver of the said vehicle stopped and left the vehicle on the road in abandoned condition and fled away from there. I then detained the said vehicle and found it loaded with river bed materials.

Under the above noted circumstances there was a sufficient reason to believe that the above noted accused driver of the above noted vehicle was engaged in illegal mining of river bed materials for transporting the same without a valid license or documents. Hence, I seized the detained vehicle having registration no WB-15D 1265 loaded with river bed materials under proper seizure list. The seizure was made in between 20.35 hours to 20.39 hours under proper videography.

I, therefore pray before your kind self that a specific case under appropriate section of Law may kindly be initiated against the driver and the owner of the Vehicle bearing Display no. WB-15D 1265 and arrange for its investigation.
