my drinking water with urine.

Respected Sir/Madam,

I Kanna Kesay Bhutia w/o Bekain Subba,
Resident of Remipol nandoh East Sikkim hereby
lodge this complaint seeking immediate registration
of an FIR under the Bharatiya Nyaya Sanhita, 2023
(BNS) against the owner and staff of NU ERA The
Furniture dealer, Siliguri, for committing grave, inhuman
and repeated criminal acts against me. Details of
the Accused: Jitesh Gupta, owner, NU ERA, The Furniture
Dealer Shop Manager Other staff member present at
the shop at the relevant time. Transaction Details:
I had booked a sofa on 19.01.2026 set worth ₹1,15,000
(Rupees one lakh fifteen thousand only) in advance
and promise to delivery the product on 21.01.2026
Date & Place of incident Date: - 21.01.2026 Place:
NU ERA - The Furniture Shop.

FACTS OF THE CASE:

On the above date, I visited the shop to take
delivery of my sofa set. The product was already packed.
I requested to check the sofa set once before delivery

which is my lawful right - as a customer. At this point, the shopkeeper became aggressive, and a heated argument followed. During this confrontation, the manager verbally abused me, humiliated me, and attempted to touch me inappropriately, causing fear, humiliation, and mental distress. During this time my water bottle was kept on the manager's table. After the argument appeared to be settled and I was busy packing my goods and I felt thirsty and went to drink water which was on the manager's table and I suddenly noticed a foul smell and I drank a sip ^{and} found it ~~was~~ contaminated with urine in my bottle.

Unknowing I consumed it. They verbally abused me, used insulting and threatening language, tried to push me out of the shop causing further humiliation, fear, and physical and mental trauma. This clearly shows their criminal intent, lack of remorse, and continuous harassment. Seriousness and impact. The Act committed by the accused are inhuman, intentional and degrading. The have endangered my physical health and life caused severe mental trauma and humiliation violated my dignity and safety as a woman show complete disregard for law. Offence attracted (Bharatya Nyaya Sंहिता, 2023) ~~to~~ the Accused persons are liable under the following provisions of BNS, 2023 among others.

Section 74 BNS - Assault or use of criminal force against a woman with intent to outrage her modesty.

Section 122 BNS - Voluntarily causing hurt by administering a harmful or noxious substance.

Section - 271 BNS - Malignant or negligent act likely to spread infectious dangerous to life

Section 115 BNS : Voluntarily causing hurt (Pushing-Physical force)

Section 356 BNS : Intentional insult with intent to provoke breach of peace.

Section 351 BNS: Criminal intimidation.
