would like to inform you that - today i.e. 26.01.2026 at
about - 10:45 hr when my big brother namely Chandan
Singh crossing Dimp Company near Shiv Mandir Pradhan
Nagar above mention persons Lal Bihari @ Shamber,
Bhubai along with their associates restrain the way of
my brother and started quarrelling with him. When my
brother tried to protest the alleged persons physical assaulted
intention to kill my brother. Later more 5/10 person came
and they also beaten badly to my brother, they all carry
deadly weapon and planned for this all incident - they
all threatened with dire consequence, as a result - my
brother sustained injured and covered with blood.

with the help of local people my brother shifted at
nearest hospital and now he is admitted at - Siliguri
District Hospital (Civil). Now my family are scared with
this incident - as because they are threatened to my
brother that - they will kill to my brother.

Hence, I pray before you may kindly consider my
requisition and take legal action against them.
