Sir,
I, Smt Puja Mahato, Wife of Sri Lalan Mahato, resident of 2/6, Baghajatin Colony, Ward No. 2, P.O. & P.S. Pradhan Nagar, Siliguri, District Darjeeling, would like to inform you that on 21.12.2025 one Chandan Singh, Son of Sanjay Singh, resident of Gurung Basti, Ward No. 3, near Saint Thomas School, under P.S. Pradhan Nagar, District Darjeeling came before my husband and requested my husband to pay him a sum of Rs. 20,000/- (Rupees Twenty Thousand) only as he was in dire need of money. Considering his necessity, my husband Lalan Mahato paid him the said sum of Rs. 20,000/- (Rupees Twenty Thousand) only and at the time of receiving the said amount, said Chandan Singh assured my husband to pay back the entire amount within a week from the date receiving the said amount. After elapse of considerable time when my husband asked him to refund the said amount, said Chandan Singh told my husband that he will surely pay back the said amount to my husband by 23.01.2026. Said Chandan Singh fails to refund the borrowed amount even after the extended time and was further avoiding to meet my husband just to avoid payment. Finding no other alternative, my husband on 24.01.2026 went to his house but there also, he denied to meet with my husband. Yesterday on 25.01.2026 at around 11.00 pm when my husband was returning home, near Jyotirmoy Club, situated at Gurung Basti, Ward No. 3, P.S. Pradhan Nagar he saw Chandan Singh was playing cards along with Nikesh Chowdhury and 5 other unknown persons and at that time, my husband requested said Chandan Singh to pay back the borrowed amount, but very surprisingly, said Chandan Singh denied of receiving any amount and further started to throw abusive languages towards my husband and not only that said Chandan Singh suddenly started to assault my husband with fist and blows and when my husband raised protest, said Chandan Singh, Nikesh Chowdhury and other five persons assaulted my husband brutally with iron rods and wooden sticks causing bleeding injury on his head, chest etc and when my husband to save his life tried to escape from there said Chandan Singh and Nikesh Chowdhury and other 5 friends caught my husband again and pushed him on the ground and started to kick on his chest, abdomen and on his head aiming to kill him.

At that time, one BabluMahato, Son of Late NathuMahato of our locality saw my husband assaulting by the said persons, then with the help of other persons somehow rescued my husband from their grip and brought to our home in a critical unconscious condition and soon I shifted my husband to the Siliguri District Hospital at around 12.30 p.m. where the doctor, considering the physical assault and injury sustained by my husband, admitted my husband in the hospital and at present my husband is admitted there in critical condition.

Today, i.e. on 26.01.2026 in the morning at about 10:00 am. I saw said Chandan Singh near Baghajatin Colony MuktaManch and when I told him that I would lodge written complaint against him for assaulting my husband, said Chandan Singh became aggressive and slapped me, for which I fell down, but he did not stop rather, said Chandan Singh started to assault me with filthy and vulgar languages, tore my blouse and thus tried to disrobe me in public and further gave threat if I go to the police station for lodging any complaint, he will kill me and my husband. At the time of assaulting me by said Chandan Singh, After hearing my hue and cry said Chandan Singh fled away from there. Thereafter I was about to go to the police station to lodge FIR, suddenly I heard that said Chandan Singh along with his other associates again attacked upon some of my family members, who were going to the Hospital, near Milan Tailor, Pradhan Nagar, Siliguri and chased them upto the Junction having lathi and sharp cutting weapon in their hand, but somehow they took shelter in a hotel nearby and saved their lives otherwise they would have killed them.

As my husband was unconscious, considering his treatment I was unable to lodge FIR to the police station in time regarding his assault, but today's incident towards a women compelled me to come to the police station ignoring my husband's serious condition to lodge a FIR against Sri Chandan Singh, Nikesh Chowdhury and other five of their friends for the offence committed by them as mentioned above.

I therefore request you to lodge FIR against the above named persons and take necessary strict legal action against them as per the law.
