I, Kanchan Saha, S/O - Kala Chand Saha, resident of
Baghajatin Colony, Pradhan Nagar, Doojelling, West Bengal -
734003, would like to report that on ^{26th January 2026.} around 7 PM,
my father was walking near circuit Howe, Champasari,
when two person unknown on a vehicle bearing No :-
WB 73 K 0847 (Activa 125 DISC, Grey colour, registration - 21st Nov 2021
hit him from behind at high speed. He sustained grievous
injuries - forehead, leg and hip bone fractures. Initially
treated at North Bengal Hospital, but now is referred to
Neotia Hospital in serious condition (ICU). The accident
occurred due to rash and negligent driving offence :-
IPC 279 (Rash/Negligent Driving), 338 (Grievous Hurt),
M.V. Act 184 (Dangerous Driving, possibly 30A 304A IPC
(culpable Homicide not amounting to murder if
condition worsens). Given serious injuries, request
non-bailable warrants against accused.

I request the police officers to take necessary
action against the accused and help in providing
protection and assistance for medical treatment.
