Subject Written Complaint

Respected Sir,

I, Kauleshwer Prasad proprietor of Guptajee Food Products having its office at Damragram Dagapur, Post Office and Police Station:- Pradhan Nagar, West Bengal, Pin-734003 would like to bring the follow facts to your knowledge.

1. That on 27.02.205 at around 8 p.m., My company's Goods Carrier Truck having its vehicle number .WB63G4247 was passing through Dagapur Tea Estate to the Companies premises
2. That Md firoz (bhola) S/o zabar ali, Mehaboob alam S/o Safir alam, Ibul haque S/o md mukul, Jamir ali S/o md mukul all resident of Dagapur Tea Estate forcefully stopped my Company's vehicle by blocking its way using their E-rikshaw.
3. That all the above name accused persons got down of the E-rikshaw carrying rods in their hands and damaged their own E-Rikshaw windshield to show that they were hit by the said truck and their e-rikshaw was damaged and on the same pretext the above named person tried to extort money from the victim above mentioned.
4. That the truck driver and his associate objected to the conduct of the accused persons Named Sanatan Barman S/o of Sri.Avinash Barman and Kartick Mali Son of Sri.Baladeb Mali confronted them for having faked a false accident for simply extorting money from them.
5. That the accused persons on being denied to hand over the cash, damaged the company's truck being no.WB73G4247 and also hit the driver and his associate with rods causing bleeding and grave injury. The above named accused persons robbed the driver and his associate by forcefully extorting a sum of around Rs 60,000/- (Rupees Sixty Thousand Only) . The accused person also snatched away silver chain of the driver during the said incident.
6. That the driver and his associate informed about the said incident to the concerned staff at the company who reached the place of incident therefore upon seeing them the said above name accused persons fled from the spot.
7. That the concerned police officials were also informed about the said incident who reached the place of accident and verified the claim of the driver and his associate.
8. That the police officials also visited the house of the above named accused persons but not to its surprise the accused persons along with his family absconded from their house locking the same.
- 9: That subsequently the medical of the driver and his associate was also conducted

at Siliguri District Hospital wherein it was found that they had sustained bleeding and also glass particle was found in their eyes therefore damaging their eyes sight as well.

Under such circumstances, I most respectfully request that appropriate and lawful action be taken against the accused persons namely Md firoz (bhola) S/o zabar ali, Mehaboob alam S/o Safir alam, Ibul haque S/o md mukul Jamir ali, S/o md mukul upon due consideration of the facts and circumstances stated herein. The acts complained of disclose the commission of serious cognizable offences involving wrongful Restraint, use of criminal force, causing of serious bodily injury, robbery, attempt to murder and common intention therefore warrant immediate inquiry and action in accordance with law.

I humbly request that the matter be looked into with due seriousness and that such steps as deemed fit and proper be taken so as to secure the ends of justice.
