I, **Asim Singh**, wife of Ashok Sawria, resident of Dimbuline, Mohorgon Tea Garden, P.O. Gulma, P.S. Pradhan Nagar, District Darjeeling, West Bengal – 734009, do hereby lodge this First Information Report for your kind consideration.

That my husband Ashok Sawria is the lawful owner and in possession of one Scooty, details of which are given below:

- Registration No.: WB-73-N-9573
- Chassis No.: D626AK40S3H4641
- Engine No.: EK4HS3133724
- Model: TVS Jupiter 125
- Colour: Harlequin Blue

That on 26/01/2026, at about 2:00 PM, when I came out of my house, I noticed that the aforesaid Scooty was not present at its usual parking place. Initially, I thought that someone from the family might have taken it or that it might be a prank, and therefore waited for some time.

Thereafter, I thoroughly searched the nearby areas and all possible places, but despite my best efforts, the Scooty could not be traced. It has become clear that some unknown person(s) have dishonestly removed and stolen the Scooty from its parking place.

That the said act amounts to theft, committed by unknown accused person(s). Hence, I have approached your police station seeking necessary legal action.

I therefore humbly request you to kindly register an FIR, investigate the matter, and take necessary steps to trace and recover the stolen Scooty at the earliest and to proceed against the offender(s) in accordance with law.
