Subject: - F.I.R.

Sir,

With due respect, I am producing herewith two (02) accused persons namely (i) Saroj Sahani (32 yrs) S/O Buddhan Sahani of Rajendra Nagar, Coolipara, Ward No-01, PS- Pradhan Nagar, Dist. Darjeeling and (ii) Nabin Roy (32 yrs) S/O Sarban Roy of Siliguri Junction, Coolipara, Ward No-01, PS- Pradhan Nagar, Dist. Darjeeling under arrest and the following articles under proper seizure list viz :- One white colour nylon bag containing two paper made cartoons each cartoon containing 12 (twelve) bottles of Magic Moments Grain Vodka i.e total (12 x 02= 24) bottles, each bottle containing 750 ml i.e total (24 x 750 ml) = 18 lts marked as Exhibit "A" out of which one bottle of the same taken as sample from each cartoon for examination and marked as Exhibit A1 & A2.

I ASI Biplab Kr Das of Pradhan Nagar PS, SPC do hereby lodged this written complaint against the above mentioned two arrested accused persons namely (i) Saroj Sahani (32 yrs) S/O Buddhan Sahani of Rajen Nagar, Coolipara, Ward No-01, PS- Pradhan Nagar, Dist. Darjeeling and (ii) Nabin Roy (32 yrs) S/O Sarban Roy of Siliguri Junction, Coolipara, Ward No-01, PS- Pradhan Nagar, Dist. Darjeeling to the effect that on 29.01.2026 at about 14.15 hrs, I received specific secret information that two persons running illegal business of seling ID liquor at Ganapati Store, near SNT Bus Stand near Siliguri Junction and they store huge quantity of ID liquor at the said shop without any valid documents with a view to sale the same to their design customers for their wrongfull gain. Accordingly, I diarized the fact in PS General Diary vide Pradhan Nagar PS GDE No. 1735 dated 29.01.2026, and the matter was intimated to you. As per your kind order and direction, I along with ASI Prabal Sarkar, ASI Bikash Roy and other force personnel proceeded to the spot by government vehicle with investigation kit to verify the veracity of the information.

At about 14:55 hours, we reached in near SNT Bus Stand, Siliguri Junction under PS- Pradhan Nagar, Dist. Darjeeling and contacted with my source and being pointed by the source we entered into Ganapati Store, near SNT Bus Stand near Siliguri Junction and found two persons were inside the said shop. We disclosed our identity as Police Personnel (as we were in civil dress for our convenience). On interrogation they disclosed their identity as noted above and also disclosed that they are the owner of the said shop. On search the above noted I/D liquor were recovered from their shop styled as Ganapati Store. On demand they failed to give and documents in respect of the above mentioned I/D liquor recovered from their joint possession. On further interrogation they admitted their guilt and disclosed that they are running a business of illegal ID liquor without any valid documents since last 06/07 month for their wrongfull gain. When their involmvement of selling and storing illegal I/D liquor illegally was established, then I seized the above mentioned I/D liquor under proper seizure list in presence of independent witnesses. The entire process of search and seizure was made under the coverage of videography at the spot as per norms of BNSS in between 15.45 hrs to 16.15 hrs and subsequently arrested the above mentioned two accused persons under proper memo of arrest and observing all the formalities of arrest. I also informed them regarding ground of their arrest for violating the norms of Bengal Excise Act and brought to Pradhan Nagar PS for further investigation.

Under the above mentioned fact and circumstances, I pray to you that a specific case under Bengal Excise Act may kindly be initiated against both the arrested accused persons namely (i) Saroj Sahani (32 yrs) S/O Buddhan Sahani of Rajendra Nagar, Coolipara, Ward No-01, PS- Pradhan Nagar, Dist. Darjeeling and (ii) Nabin Roy (32 yrs) S/O Sarban Roy of Siliguri Junction, Coolipara, Ward No-01, PS- Pradhan Nagar, Dist. Darjeeling and may arrange to cause its investigation.
