I **MR. CHANDU SINGH**, Son of Mohan Singh, aged about 19 years, Indian by Nationality, Hindu by religion, resident of prakash Nagar, Shyani basti, Ward No. 43 of S.M.C., Post Office :- Sevoke Road, P.S. Bhaktinagar, Dist:- Jalpaiguri, in the state of West Bengal, Pin:- 734001

I would like to inform you about an incident which was occurred with me on **28/01/2026** at about between 10:20 P.M. to 10:55 P.M. at Champasari Anchal, near Anchal Bridge in front of Chomin Momo Shop, Champasari, Darjeeling, when I along with my One friend (namely Praveen Kumar Chauhan) went to have Momo Chowmin near Anchal bridge there was one unknown person also present, who was asking money for illegal activity but I denied to do favour to him, So that that unknown person started quarrelling and started to brutally attacked through Sharp Weapon (knife) with **full intention to kill me**. So that I got injury in my face (**below Right Eye, Over Nose**) and through Knife that culprits hit in my body Chest. I became unconscious at the place my above mentioned friend and local people try to caught the culprits but that person flew away from there in **Black Colour Activa**. My friend (Praveen Kumar Chauhan) took me to Siliguri District Hospital and save my life So that I got **1 (one) stitch** in my body Chest and doctor advice to CT scan of Brain as soon as possible.

In such circumstances, finding no other alternative I come before you with this present complaint and request you to take necessary action in respect of the above matter as per law and to help me to get justice and provide strict punishment to the culprits.
