**Subject:** Complaint against Kiran Singh @ Kaira , Avni & others for their criminal and wrongful activities

Dear Sir,

**I, undersigned** , Ashmaya Rao Yadav, D/o - Dalip Singh, aged about 26 years, by faith Hindu, by occupation employed, residing at Shanti Niwas , near Radha Krishna apartment, Shastri Nagar, Pin-734001, do hereby most respectfully submit the following facts for your kind consideration:

1. That during my professional engagement period there is a development of friendship with one Kiran Singh @ Kaira (8653200424) and her sister Avni (8670823244).
2. That recently, I was subjected to a barrage of abusive and slang language, and due to the objectionable behavior of Kaira, I started to avoid her. And therefore, at the extreme level of her indecent behavioral approach to me, I compelled to restrain any communication with her and blocked her no since 07.01.26 for few days. Since then, she started threatening me by stating that she would circulate my name and mobile number in the open market portraying me as a call girl. Therefore, she blocked my mobile number.
3. That due to such threats and out of fear of social, professional and/or public humiliation, I was compelled to leave the said job immediately.
4. That as my mobile number was blocked, I had no option to contact her directly for the purpose of collecting my belongings which were kept with Kaira.
5. That therefore on 10.01.26 in and round 10'clock in the night, I contacted her sister, namely Avni, solely for the purpose of requesting to return me and collecting my belongings which were kept with Kaira.
6. That instead of cooperating, she started to pick a fight and troubled me unnecessarily. She used abusive and slang language and further threatened me by stating that I would have to face serious consequences, and warned me that they would kill me if I disclosed the matter to anyone else. These activities have created a hostile and unsafe environment for me.
7. That from **10/01/2026 at about 1:44 a.m.** onwards, I have been receiving continuous calls, SMS messages, obscene images, and abusive proposals from various unknown mobile numbers (**Mobile Numbers are listed below**). The callers and/or senders are portraying me in a derogatory manner, offering me for unwelcome sexual relationships and explicit sexual overtures in exchange for money and requested for sexual favors. They have been making sexually colored remarks by using filthy, obscene, and abusive languages and referring to me as a "call girl," thereby causing severe damage to my dignity, reputation,

and mental peace. (A photocopy of the screenshots of the call logs and messages are annexed hereto as evidence).

8. That I am undergoing immense mental trauma, fear, and harassment due to the above acts, and I reasonably apprehend serious danger to my life and reputation.
9. That I have a strong and reasonable suspicion that the said Kaira and her sister are deliberately spreading my mobile number among mischievous and antisocial persons with the intent to harass, defame, and intimidate me.
10. That the aforesaid acts clearly constitute offences of criminal breach of trust, criminal intimidation, intentional harassment, unwelcome and explicit sexual overtures, request for sexual favors, sexually colored remarks, online stalking, and other cognizable offences, which have caused me severe mental agony, humiliation, defamation and a genuine apprehension of threat to my life and personal safety.

In view of the above facts and circumstances, I humbly request you to kindly take immediate and appropriate legal action against Kiara, Avni & others under relevant provisions of law and I request you to take immediate action to identify the platforms where my number is circulated with such derogatory labels and ensure its removal to prevent such wrongful activities further. Till on the date in day-night basis i have been subjected deliberate torture through phone calls and sending obscene what's app videos and audio messages.

I undertake to fully cooperate with the investigation and shall provide any further information as and when required.
