
Sir,

I, Shri Shusanta Kumar Roy Son of Late Suresh Chandra Roy, residing at Plot no.A-1510, Uttorayan, P.O. & P.S. Matigara, District Darjeeling, do hereby lodge a written complaint against (1) Shri Pradip Ghosh Son of Late Trailakya Nath Ghosh and (2) Smt. Chhanda Ghosh, Wife of Shri Pradip Ghosh, both residents of "Debarup", Deshbandhupara, Near Pipe Line, Siliguri.

Both of them are forcefully restraining my employee to remove his belongings and also forcefully restraining the free ingress and outgress movement of the belongings of the present employee who is staying in my said flat. When my employees protested, during that time the said Pradip Ghosh and his wife Chhanda Ghosh created nuisance by abusing in filthy languages to my said employees and tried to cause damage to their belongings. In view of the foregoing, I request you to kindly take necessary action against both the above named persons as per law and punish them according to law.
