Chhanda Ghosh, W/O Sri Pradip Ghosh resident of South Deshbandhu Para, Ustad Amir Khan Sarani, Ward No. 30, District Darjeeling would like to draw your kind attention on the following effect that my husband filed a suit against the Dr. Sushanta Roy and another before the Ld. Civil Judge Senior Division Siliguri for Eviction, Cancellation of deed alongwith an Injunction Application for which the Ld.
