Sir,

In producing herewith one (01) accused person namely Raja Thatal (40), S/O Late Sarman Thatal of Rajib Nagar, near Sramik Bhawan, W/No. 46, PS. Pradhan Nagar, Dist. Darjeeling under arrest along with the following seized articles under proper seizure viz:- (i) One multicolor nylon bag containing one paper made cartoon, which contains 20 bottles of "HIMALAYAN GOLD 60 UP" India made liquor each bottle containing 600 ml i.e, total (20 x 600 ml) = 12 ltrs marked as Exhibit "A" out of which one bottle of the same taken as sample for examination and Marked as Exhibit "A-1".

I, ASI Biplab Kumar Das of Pradhannagar Police Station, Siliguri Police Commissionerate, do hereby lodge this written complaint against the above-named arrested accused person to the effect that on 30.01.2026 at about 20:40 hrs, I received reliable source information that one person was carrying a huge quantity of illicit liquor illegally at Siliguri Junction under P.S. Pradhannagar, District Darjeeling, with the intention of selling the same to his designated customers for wrongful gain. Accordingly, I informed the matter to you and, as per your kind order and direction, I along with force rushed to the spot, which was duly entered vide Pradhannagar P.S. GDE No. 1817 dated 30.01.2026. Upon arrival at Siliguri Junction and being identified by the source, a raid was conducted and one person was detained at opps. of SJDA Building, Siliguri Junction under Pradhan Nagar PS, SPC. On interrogation he disclosed his identity as noted above. On search the above noted illegal liquor was recovered from his possession which he kept in a multicolor nylon bag. On demand he failed to produce any valid documents or licence to selling such liquor. As he willfully violated the norms of Bengal Excise Act, accordingly, I seized the above noted illegal liquor under proper seizure list in presence of available independent witnesses from the possession of Raja Thatal (40), S/O Late Sarman Thatal of Rajib Nagar, near Sramik Bhawan, W/No. 46, PS. Pradhan Nagar, Dist. Darjeeling. The entire process of search and seizure was made in between 21.55 hrs to 22.25 hrs under the coverage of videography as per norms of BNSS. Subsequently, I arrested the above noted detained person namely Raja Thatal (40), S/O Late Sarman Thatal of Rajib Nagar, near Sramik Bhawan, W/No. 46, PS. Pradhan Nagar, Dist. Darjeeling after observing all the formalities of arrest and informing him regarding the grounds of his arrest for violating the norms of Bengal Excise Act and brought to Pradhan Nagar PS for further investigation.

Under the above noted fact and circumstances I, therefore pray that a specific case under proper section of law may kindly be started against the above noted arrested accused person namely Raja Thatal (40), S/O Late Sarman Thatal of Rajib Nagar, near Sramik Bhawan, W/No. 46, PS. Pradhan Nagar, Dist. Darjeeling for violating the provisions of W.B. Excise Act.
