Sir,

In producing herewith five (05) accused persons namely 1)Mithun Das (20) SO-Narayan Das of Janatapara, PS New Jalpaiguri Dist Jalpaiguri 2)Monoranjan Das (36) s/o Rabi Das of Ambikanagar PS New Jalpaiguri Dist Jalpaiguri 3) Bittu Debnath (23) s/o Pralad Debnath of Phasidewa, Rishi Road, PS- Phasidewa, Dist- Darjeeling 4) Kandru Mahammad (37) s/o Najimuddin Mahammad of Gothmabari PS New Jalpaiguri Dist Jalpaiguri 5) Mehabub Alam (22) s/o Jamirul Mahammad of Bhaktinagar Chuniatala PS Phasidewa Dist Darjeeling along with seized articles via:-

1. One iron made sword approx length 03 (Three) feets along with wooden handle.
2. One iron made Axe approx length 02 (Two) feets along with bamboo handle
3. One iron made hammer approx length 01 (One) Feet along with bamboo handle.
4. One iron made Khuriya approx length 03 (Three) feets.
5. One electric torch light
6. One blue colour Nylon rope.

I SI Tanmoy Kundu of New Jalpaiguri PS, SPC do hereby lodge a written complaint against the above noted accused persons and others 05/07 persons to the effect that on the night 25/01/2026 at 00-05 hrs received secret source of information to the effect that some miscreants with deadly weapons assembled in a dark place at Shitalapara Ground under NJP PS with a view to commit dacoity, Accordingly without waste any time I informed the matter to you and duty officer of PS and noted in NJP PS GDE No. 1415 dt. 25/01/2026 . As per your kind direction at 00-05 hrs myself along with ASI Nilam Swarnakar C/1462 Sajan Tamang, C/453 Uttam Dey, VP-13 Jamirul Islam VP 08 Laxman Roy left from PS for Shitalapara Ground to verify the veracity of the information and to work upon it. We reached near the spot as confirmed by the source at about 00-10 hrs and stopped our vehicle at a considerable distance from that place and we started walking towards the said place and we reached near the Shitalapara Ground under NJP PS, found a group of 10/12 persons assemble and gossiping in a dark place at that place. We started approaching them slowly ambushing ourselves in the darkness. But unfortunately one of them see the police and try to flee away from there. Somehow, after a hot chase we could able to apprehend the above noted five (05) persons and the others 05/07 persons managed to flee away from the spot taking the advantage of darkness. On interrogation they disclosed their identity which was not verified and they also stated that they along with their other associates assembled there with a view to commit dacoity after making full preparation in the adjacent area of Shitalapara Ground under NJP PS. Thereafter all the apprehended persons were searched and in presence of independent witness I conducted search and seizure. During searching I found and recovered the above noted articles from their possession as well as Place of occurrence and seized the same as per proper seizure list duly sign by them and the process of search and seizure as been captured in video graph as per provision of law . Accordingly I arrested the above noted accused persons u/s 35 BNSS after informing the ground of arrest and dully issue of memo of arrest. The whole seizure was made between 00-15 hrs to 00-25 hrs and the all persons were arrested with proper memo of arrest.

So I pray before you that a specific case may kindly be started against 1)Mithun Das (20) SO-Narayan Das of Janatapara, PS New Jalpaiguri Dist Jalpaiguri 2)Monoranjan Das (36) s/o Rabi Das of Ambikanagar PS New Jalpaiguri Dist Jalpaiguri 3) Bittu Debnath (23) s/o Pralad Debnath of Phasidewa, Rishi Road, PS- Phasidewa, Dist- Darjeeling 4) Kandru Mahammad (37) s/o Najimuddin Mahammad of Gothmabari PS New Jalpaiguri Dist Jalpaiguri 5) Mehabub Alam (22) s/o Jamirul Mahammad of Bhaktinagar Chuniatala PS Phasidewa Dist Darjeeling and other 10/12 persons and arranged for its investigation.
