Sir,

In producing herewith 01 (one) arrested accused person namely **Biswajit Barman** (23 yrs approx), S/O- Dinesh Barman of Rananagar, PO+PS- Matigara, Dist- Darjeeling along with the following seized article under proper seizure list :-

One (01) EICHER dumper displaying Reg. No. WB 73 G 2841 loaded with riverbed materials (Sand).

I ASI Chandra Prakash Adhikari of Matigara P.S, SPC do hereby lodge a Complaint against the above noted accused person to the effect that on 29.01.2026 at 13:30 hrs, received an information from reliable source that one dumper vehicle displaying Reg. No. WB 73 G 2841 loaded with illegally mining riverbed materials(sand) is going towards Tumbajote from Chhotu Ghat Rananagar under Matigara PS through Patiramjote and accordingly informed to I/C Matigara PS and as per his kind direction myself along with other officers and forces left the PS to work out the information. This refers to Matigara PS GDE No- 1968, Dt- 29.01.2026. Under information and kind order of I/C Matigara P.S on arrival at Jora Bridge, Tumbajote under Matigara P.S, Dist- Darjeeling area, I found one dumper displaying Reg. No. WB 73 G 2841 coming towards Jora Bridge Tumbajote. Subsequently, I managed to stop the vehicle at Jora Bridge Tumbajote. On asking the driver of the dumper he introduced his name and address as Biswajit Barman (23 yrs approx), S/O- Dinesh Barman of Rananagar, PO+ PS- Matigara, Dist- Darjeeling. Further on asking the driver of the dumper to produce valid documents / papers of the said riverbed materials but he failed to produce any valid documents or papers in respect of the said riverbed materials. Further on being asked he admitted that he loaded the riverbed materials from the Chhotu Ghat, Rananagar under Matigara PS area without any proper royalty/documents.

There was a sufficient reason to believe that the above noted accused driver and above noted vehicle and the owner of the vehicle have procured the river bed materials illegally without any proper royalty/ papers as per rule, for selling clandestinely for their wrongful gain. Accordingly, I seized the above noted loaded EICHER dumper displaying Reg. No. WB 73 G 2841 along with riverbed materials under proper seizure list and arrested the above noted driver. The whole process of search, seizure and arrest was made in between on 29.01.2026 in between 13:55 hrs to 14:10 hrs. The whole process of seizure was made under videography.



Therefore I pray before you a specific case may kindly be started against the above noted accused person namely **Biswajit Barman (23 yrs approx), S/O- Dinesh Barman of Rananagar, PO- Matigara, PS- Matigara, Dist- Darjeeling** and the owner of the seized vehicle under proper section of law and arrange for its investigation.
