Respected Sir/Madam,

I, Bina Debnath, wife of Arup Ghosh, resident of Shantipur, Bairatisal, P.O. Kadamtala, P.S. Matigara, Siliguri, West Bengal, 734011, am filing this formal complaint regarding a premeditated crime.

The accused, Aamir Shuhel and Dipa Yelmo, befriended me and frequently used my phone under the pretext of calling family. I now believe they used these opportunities to spy on my passcode. Furthermore, they were residing at my premises and have not paid their outstanding rent.

On 30/01/2026, while I was unwell and resting, Dipa Yelmo borrowed my phone for an "urgent call." When I checked 10 minutes later, both had fled. They stole my mobile phone, a small gas cylinder, and a mixer grinder. After waiting for an hour, I discovered they had used the phone to fraudulently transfer ₹84,000 from my SBI Account (No. 10195783163).
