Jalpaiguri. 2. Rabi Sarkar (20 yrs Approx), S/O- Lt. Dipu Sarkar of Dashratpally, PO. Sevok Road, PS. Bhaktinagar, Dist. Japaiguri. 3. Sambhu Sarkar (24 yrs approx), S/O- Lt. Dipu Sarkar of Dashratpally, PO. Sevok Road, PS. Bhaktinagar, Dist. Japaiguri. 4. Kamal Debnath (30 yrs approx), S/O- Kajol Debnath of Bagajotin Colony Champasari, PO+PS. Pradhannagar, Dist. Darjeeling. 5. Mangal Chowhan @ Chhoton (30 yrs approx), S/O- Lt. Rama Chowhan of Debidanga Bazar, PO+PS. Pradhannagar, Dist- Darjeeling and the following articles under seizure :-

1. One iron made Sabol measuring approximately 03 feet from the possession of accused named Ashok Sahani.

I, ASI Dipak Kr. Chhetri of Matigara PS, Siliguri Police Commissionerate beg to state that on 31.01.2026 at 23:35 hrs, received a secret source information that a gang of miscreants were assembled in an open place at dry fish market near kabarthan under Matigara PS. Dist:- Darjeeling with deadly weapons and making preparation for committing dacoity at Matigara Bazar area. Accordingly, I informed the fact to I/C, Matigara PS and as per his kind order myself along with ASI C.P. Adhikari, C/219 Sanatan Chitrakar, C/868 Sujal Roy, C/523 Sanjit Kundu all are of Matigara PS, Siliguri Police Commissionerate left for dry fish market near kabarthan, PS- Matigara, Dist.- Darjeeling to work out the information in hand vide Matigara PS GDE No. 2143 Dated- 31.01.2026. At about 23:45 hrs we arrived at dry fish market near Kabarthan under Matigara PS. After arrival of the spot and as identified by the source we found that 10/12 persons were assembled in an open place at dry fish market near kabarthan under Matigara PS, Dist.- Darjeeling and they were whispering in a very low voice. Accordingly we cordoned the place properly and approach towards them very slowly and carefully. But seeing the police party they started to flee away but we managed to apprehended 05 (five) persons of them. On interrogation, the apprehended accused persons disclosed their name and identity as noted above (not verified) and also disclosed that they assembled there for making preparation for committing dacoity in Matigara Bazar area. They also stated that others 06/07 associates were able to fled away from the spot by taking advantages of darkness. On being searched of the apprehended accused persons, found the above noted articles from their possessions. Accordingly, I seized the above noted articles under proper seizure list and arrested the above noted 05 (five) accused persons under proper memo of arrest and observing all the formalities of arrest. The search seizure was made in between on 31.01.2026 at 23.48 hrs to 01.02.2026 at 00.02 hrs. The whole process of search & seizure was made under WB - E-Sakshya Application.

REPORT

Under the above noted fact and circumstance, I therefore pray to you that a specific case under proper section of law may kindly be started against the arrested accused persons namely 1. Ashok Sahani (20 yrs approx), S/O- Lt. Ramprit Sahani of Prakashnagar Sahani Busty, PS. Bhaktinagar, Dist. Jalpaiguri. 2. Rama Sarkar (20 yrs Approx), S/O- Lt. Dipu Sarkar of Dashratpally, PO. Sevok Road, PS. Bhaktinagar, Dist. Jalpaiguri. 3. Sambhu Sarkar (24 yrs approx), S/O- Lt. Dipu Sarkar of Dashratpally, PO. Sevok Road, PS. Bhaktinagar, Dist. Jalpaiguri. 4. Kamal Debnath (30 yrs approx), S/O- Kajol Debnath of Bagajotin Colony, Champasari, PO+PS. Pradhannagar, Dist. Darjeeling. 5. Mangal Chowhan @ Chhoton (30 yrs approx), S/O- Rama Chowhan of Debidanga Bazar, PO+PS. Pradhannagar, Dist. Darjeeling and others and arrange for investigation.
