Subject: Complaint regarding illegal occupation and erection of temporary pandal on SJDA government land at Porajhar Kawakhali.

Respected Sir,

I SI Tanmay Kundu of New Jalpaiguri PS most respectfully beg to submit that it has been reported that members of the Porajhar Kawakhali Bhumi Rokha Committee, under the leadership of one Mithun and others, have illegally entered and occupied government land belonging to the Siliguri Jalpaiguri Development Authority (SJDA) situated at Porajhar Kawakhali.

It is stated that during the night hours, taking advantage of darkness, the persons namely 1) Mithun Sarkar, Mithu Das Mallik, Rita Sarkar, Dipu Sarkar, Ananda Mandal, Tapashya Roy, Rina Mandal, Arjun Biswas, Paritosh Sarkar, Guru Bhakta Mallik, Sudhir Sarkar, Badal Dey, Parul Sarkar and others illegally entered to the Govt. land and erected a temporary pandal on the aforesaid government land without any lawful authority or permission. Further, it has been reported that about 15 persons stayed inside the said pandal throughout the entire night, thereby continuing illegal occupation of the SJDA land.

Such unlawful acts amount to unauthorized encroachment on government property and have the potential to disturb public peace and order in the locality. The intention behind carrying out the activity at night appears to be deliberate, with a view to avoiding immediate detection and lawful action.

The above facts are submitted for your kind information with a request to conduct necessary enquiry and take appropriate legal action as per law to prevent further illegal occupation of the said government land.
