**Sub: Written complaint regarding cruelty, assault, attempt to murder, criminal intimidation, desertion and illegal deprivation of maintenance.**

Sir,

With due respect, I, Smt. Anju Thapa, wife of Sri Bhagirath Thapa, residing at Salbari Haat Bazaar, Biswanath Road, near Maa Bolla Medical, P.O. Salbari, P.S. Pradhan Nagar, District Darjeeling, beg to lodge this written complaint against the following opposite parties namely (1) Bhagirath Thapa, son of Akalasing Thapa, Laju Pradhan, Wife of Shambhu Mukhia, D/o Kishore Pradhan, Kishore Pradhan, Son of not known mother of Laju Pradhan, all are residing at c/o "Glow and Groom" Salon, Gyan Jyoti More, Dagapur, Bara Gharia, P.O. & P.S. Pradhan Nagar, District Darjeeling – 734003.

Sir, that I was living a happy and peaceful married life with my husband Bhagirath Thapa and my children, daughter Ashmita Thapa and son Ashmit Thapa.

That in September 2022, I came to know that my husband was maintaining an illicit relationship with opposite party no.2 Laju Pradhan. When I protested against the said illegal relationship, my husband, opposite party no.1, assaulted me brutally and scratched my face and neck with his nails, causing physical and mental torture. In order to save my matrimonial life, I did not lodge a police complaint at that time.

That thereafter, the cruelty and oppression by opposite party no.1 continued regularly. He frequently assaulted me, abused me, and even deprived me and my daughters of food. He also repeatedly threatened to forcibly evict me and my daughters from our house at Salbari and to bring opposite party no.2 into the said house.

That on 24.12.2023, when I tried to persuade my husband for the sake of our married life, opposite party no.1 became extremely violent, assaulted me mercilessly and attempted to kill me by throttling my neck. When my daughters tried to rescue me, opposite party no.1 also assaulted them mercilessly. Since

that date, my husband has deserted me and my children and has been permanently living with Opposite Party No.2.

That from 24.12.2023, Opposite Party No.1 has not paid any maintenance to me or my children and it came to my knowledge that opposite party no. 1 Bhagirath Thapa illegally married the opposite party no. 2 Laju Pradhan and opposite party no. 1 is giving all his earnings and money to opposite party no.2 Laju Pradhan, leaving me and my daughters in financial distress.

That the house at Salbari, where I and my daughters are presently residing, belongs to opposite party no.1. He has threatened that he will sell or mortgage the said house, as a result of which I and my daughters will be rendered homeless and forced to live on the streets.

That Opposite Party Nos.2, 3 and 4 are actively assisting Opposite Party No.1 and are illegally depriving me and my children of our lawful financial and marital rights. They have also sent unknown persons dressed as policemen to our house, threatening and intimidating us to vacate the premises.

That due to continuous assault, threats, intimidation and cruelty, I and my daughters are living in constant fear. The opposite parties may cause serious harm or even kill us at any time. At present, we are somehow surviving with the help of relatives, and our condition is extremely miserable and unsafe.

Sir, finding no other alternative, I have approached your good office seeking justice. I humbly pray that you may kindly register an FIR, conduct a proper investigation, and take strict legal action against the opposite parties in accordance with law, and also provide necessary protection to me and my children.

And for this act of kindness, I shall ever pray.
