Respected Sir,


I, Pranim Rai, son of Gazendra Rai, resident of Man Mani Bhawan, Bakshila, 8/1 Convent Road, Haridas Hatta, Darjeeling, Pin - 734101 and presently residing at Panchanai Enclave, Ambhardhura, Salbari, Pin - 734009 would like to inform you that on 30.01.2026, at around 11:00 PM, I along with my two friends, namely (i) Samden Lapcha, son of Urgan Lepcha and (ii) Adnan Khallow, Son of Hidayatullah Khallow, were returning to my flat from SIT in my vehicle bearing registration number WB74 M2605. While we were on our way, a motorcycle bearing registration number WB74 AP 0290 roughly overtook our vehicle, and the rider started abusing us with filthy languages. Upon confronting them, they heatedly started arguing with us after which the said rider suddenly pulled me outside of my vehicle and started punching me on my face. Thereafter, the said rider called his men and agents after which one person namely Roshan along with 10-15 men and agents, arrived at the spot on a white Bolero and bikes and started to brutally beat me and friends on head and face with iron rods and bamboo sticks with an intention to kill on spot. The said culprits also tried to abduct me by dragging me inside their Bolero but somehow I escaped from there. Further, Roshan and his goons also started hitting and pelting stones to my vehicle with an intention to burn the same but they eloped from spot after the local people gathered around. The said incident has caused threat to our life's as we were beaten grievously by them due to which my nose has also fractured and my vehicle also got severely damaged. It is pertinent to mention here that if the locals would not had come, we would have been killed by them.

I therefore humbly request you to kindly investigate the matter and book the culprits under appropriate sections of criminal law.
