Dear Sir,

This is to inform you that I, Lakpa Tenjing Sherpa, s/o Sri Ang Phwei Sherpa resident of Teesta Pally, Government Colony, Quater No. A3/3 was brutally assaulted with fist and blunt object by one Phurba Tamang of Teesta Pally, Government Colony, Tintatti Maza Siliguri and one Chusang Yonzon of Rangbult at about 8 PM on 31/01/2026 near Sallawai. My dinner Sri Shiraj Roy was also assaulted by the abovenamed two persons. I had lost consciousness for sometime and later I was taken to Subua Block Primary Health Centre along with my dinner when I and my dinner were treated. I was referred to and advised to take a CT scan and other test and I went to Manipal Hospital, Pradharn Nagar where I was further examined. The copies of the medical documents are enclosed herewith.

Under the circumstance I would like to lodge a complaint against the said Phurba Tamang and Chusang Yonzon and pray to you to take strict action against the accused persons.

This complain is has been dictated by me in my presence and the same is written by Mr. Ugeon Lama of Teatin Tore, M.P. Road, P.O./P.S. Kusong (96-1389618) at Pradharn Nagar Police Station at about 2.50 AM after I had been discharged from Manipal Hospital.
