Subject: FIR against Dharmender Singh, S/o Baban Singh, Proprietor/Owner of BSK Traders.  
Respected Sir,

I, **Hritick Rai**, son of Sanjay Kumar Rai, resident of Biman Nagar, Bhujiapani, District-Darjeeling, Pin-734014, by profession a driver, do hereby lodge this FIR against Dharmender Singh, son of Baban Singh, resident of Pukai Jote, owner of BSK Traders (Sabji Gaddi).

1. That on 31/01/2026 at about 4 PM near Pradhan nagar Police station Regulated market Siliguri, sabji gaddi of BSK Traders, I was engaged by the Dharmender Singh, for transporting vegetables (sabji) from Muzaffarpur to Siliguri for a mutually agreed fare of Rs.7,000/-
2. That after reaching Muzaffarpur, Dharmender Singh, sent me approximately 25 kilometers beyond the agreed destination, for which he agreed to pay an additional Rs.1,000/-.
3. That later, the when I bring the vegetables from Muzaffarpur to siliguri today, he refused to pay the additional amount and stated that the payment would be made by the person who sent vegetables from Muzaffarpur. That when I contacted the sender at Muzaffarpur, he clearly stated that the payment was to be made by Dharmender Singh. Thus, both parties started shifting responsibility, and I was not paid my lawful dues. That when I objected to this unfair behaviour and protested against being treated like a beggar, I stated that I would take back the vegetables brought by me.
4. That suddenly, the Dharmender Singh, owner of the sabji gaddi BSK Traders, became violent and started slapping me, and assaulted me with rods and sticks, and using filthy languages. And during the assault, he also snatched my purse containing Rs.20,000/- in cash and forcibly snatched my gold chain.
5. That after assaulting and robbing me, he wrongfully restrained and confined me and did not allow me to leave the place, and forcibly took away my vehicle, a Bolero Pickup, without my consent as he is very powerful person having antisocial connections and also threatens me by saying "Gardan Kaat dega tera", "Police mera pocket me hey jo karna he karlo".
6. That I was kept there against my will, and only with the help and intervention of some local persons, I was somehow rescued.
7. That due to the injuries caused by him, the said local persons took me to the hospital for medical treatment.
8. That the entire incident has been captured in the CCTV cameras installed in his shop.

Therefore, I humbly request you to kindly Recover my stolen cash, gold chain and take strict legal action against him.
