Subject- First Information report

Respected Sir,

I, Rupesh Sha, Son of Ghanashyam Sha , resident of Salbari, P.O Salbari, P.S. Pradhan Nagar, District- Darjeeling, do hereby lodge this F.I.R stating the following facts.

- 1) That on 30/01/2026 at around 11 Pm while I was travelling from my Motor bike at Salbari, Gayatri Niwas and at that time 5 unknown persons who were in an intoxicated state were sitting inside their car and using filthy, abusive and obscene language in a public place.
- 2) That when I asked them to stop using such language in a public place those unknown persons became aggressive and enraged, thereafter those unknown persons came out of the car and started physically assaulting me using sticks and rods on my head, hands legs, back etc with a intention to kill me on the spot and as a result of those violent assault I suffered greivous injuries.
- 3) That hearing my desperate cry for help the local people of the vicinity came to my rescue and started chasing and beating those unknown persons.
- 4) Thereafter I was rushed to the Sukna Block Primary Health Centre hospital by the local people where I received urgent medical treatment.
- 5) That as per the instruction of the doctor I was under bed rest resulting which there has been a delay in lodging this F.I.R.

Therefore, I request you to kindly register this F.I.R against those 5 unknown persons and take appropriate legal action against them under the relevant provisions of law.
