Md. Sahil (17) s/o Md. Alamgir, were at our home at Red
light Area, Khalpara, at that time the above noted brothers

and demanded Rs. 30,000/- (Rupees thirty thousand) only from

they will come out of their house.

Sir, I immediately shifted my minor son namely
Md. Rana (16) to Siliguri Distt. Hospital & admitted there
in serious condition.
