Most Humbly, I **Afsar Hussain** Son of Late Tahir Hussain, Resident of Khalpara, M.R.Road by Lane, Ward no-7 of SMC, P.O & P.S-Siliguri, Dist-Darjeeling do here by written this F.I.R Against Persons Namely 1. **Sunny Khan** 2. **Mujibar Khan** 3. **Sahil Husaain@Khan** 4. **Rana Hussain** and 4. **Mina Begum** and two others before you to stating that today on dated-29/01/2026 around 7:30 Pm I Was Passing near hõuse of Mina Begum in that time Sunny Khan, Mujibar Khan , Sahil Husaain@Khan who are openly consuming alcohol and when I was passing the Road they broke the bottle of wine, when I try to ask them that why are they broke the bottle in front of me then suddenly they started Demanding money from me when I denied then they abusing me in filthy languages as well as started beaten me started physically assaulting me and when I start protest then sunny khan Son Late Munna Khan took out a sharp weapon knife and started attack upon me by the knife on my neck due to which cut on my hand and neck by the attack of knife and blood where started swelling by my hand, when I felt on the road and started shouting loudly then Mina begum mother of Sunny Khan along with two women started beaten me by wooden stick and they snatched my gold chain and Ring, their intention was to kill me and they all are try to kill me by hitting and attacking by sharp weapon and wooden stick. The local people save me aand take to me in the Siliguri District Hospital where doctor treat me and do banded upon my hand.
