Subject: Complaint regarding sexual harassment, criminal intimidation, house trespass, and threat to life

Respected Sir,

I, Neha Dey, daughter of Rana Dey, residing at Dabgram, Pritilata Road, Ward No. 23, PIN – 734001, PS: Siliguri, Mobile No. 9382710577 most respectfully submit the following complaint for your kind intervention and necessary legal action.

That on last night (31.01.2026) at about 9:30 PM, while I was returning home along with my two brothers, near Muchi More, Ward No. 22, one unknown drunken man was riding a motorcycle rashly and started teasing and taunting me in an obscene manner.

When we protested against his conduct, the said person abused me and my brothers in filthy language and further threatened me with rape, causing immense fear and mental trauma.

On hearing the commotion, some local people gathered at the spot and rescued us from the said person, otherwise the situation could have turned more dangerous.

Thereafter, at around 11:20 PM, two men (including the same person) somehow managed to trace our residence and came to my house. They again abused us using filthy language and threatened us with dire consequences, including rape.

Fearing for our lives and dignity, we locked ourselves inside the room and somehow saved ourselves.

Subsequently, the accused persons called my father over the phone from mobile number 7318939445 to my fathers mobile no : 7063705707 and again issued threats at 11.33 pm (Date: 31.01.2026)


Further, in the morning hours, they also called my father, Rana Dey, from mobile number 7063219231 to my fathers mobile no : 7063705707 at around 2 pm (Date: 1.02.2026) threatening that they would come again with goons and cause harm to our family.

Due to these repeated threats, we are living under constant fear, feeling completely unsafe and helpless.

In view of the above facts, I humbly request you to register an FIR against the accused persons under appropriate sections of law and to provide necessary protection to me and my family members to prevent any further untoward incident.

I shall remain ever grateful for your kind cooperation and immediate action.
