Sir,

I, Sarban Kumar Sah, son of Sri Jogindar Sah, resident of Durga Nagar, Kali Mandir, P.S- Bhaktinagar, Dist- Jalpaiguri do hereby lodge this complaint against the following accused persons namely:

That on 29.01.2026 at about 8:30 p.m. to 9:00 p.m., my uncle Parsing Sah, Dalifan Sa, was carrying passengers in his toto bearing registration no. WB-73-G-7646, while coming from Sevoke Road towards ISKCON Mandir. At that time, the above-named accused persons along with others wrongfully restrained his toto near Manokamna Hospital and demanded money. When my uncle refused to comply, they forcibly took possession of the toto and threatened him and physically assaulted him.

Thereafter, my uncle called me for help. When I reached the spot to rescue my uncle and his toto, the accused persons along with others physically assaulted me with sticks, bangles and fists with intention to kill me. They also snatched my wallet containing more than Rs. 5,000/- and two gold rings. Due to their brutal assault, I sustained multiple injuries on my face, chest and back.

The said incident was narrated to you, and you assured me that after inquiry you would register my case and provide me with the received copy of my complaint.

That again on 31.01.2026 at about 9:30 p.m. to 10:00 p.m., while I was returning from work, the above-named accused persons along with others wrongfully restrained me and again assaulted me brutally using sticks, fists and bike chains with intention to kill me. As a result, I sustained serious injuries on my face and other parts of my body, and there was bleeding from my ear. Thereafter, my neighbour Sri Krishna Rai took me to Siliguri District Hospital for treatment.

The accused persons also threatened me with dire consequences, stating that next time they would kill me and my family members, and that the police would not be able to do anything. After these incidents, my family members and I are living in constant fear and are unable to step out of our house.

In view of the above facts and circumstances, I most respectfully request your good office to kindly register my complaint, take necessary legal action against the accused persons, and arrest them at the earliest in accordance with law.
