Subject: Complaint against (1) Sarwan Sah, son of Jogindra Sah (2) Rajendra Sah, s/o unknown (3) Narsingh Sah s/o unknown (4) Ajay Sah, son of Jogindra Sah (5) Khushi Sah, daughter of Jogindra Sah (6) Dipti Sah, wife of Sarwan Sah (7) Jogindra Sah s/o unknown and two other women along with 10–12 other unknown persons all are residents of Durga Nagar, near Kali Mandir, Siliguri, P.O. Sevoke Road, P.S. Bhaktinagar, District Jalpaiguri, West Bengal.

Dear Sir,

I, Radha Mahato, daughter of Rabindra Mahato, am a resident of Durga Nagar, Dr. Rajendra Prasad Sarani, Sevoke Road, Ward No. 40, Siliguri (Municipal Corporation), P.O. Sevoke Road, P.S. Bhaktinagar, District Jalpaiguri, West Bengal – 734001. I am filing this complaint against Sarwan Sah, son of Jogindra Sah; Rajendra Sah; Narsingh Sah; Ajay Sah; Khushi Sah; Dipti Sah, wife of Sarwan Sah; Jogindra Sah; two other women; and 10–12 other unknown persons, all are residents of Durga Nagar, near Kali Mandir, Siliguri, P.O. Sevoke Road, P.S. Bhaktinagar, District Jalpaiguri, West Bengal. All of whom acted together.

On 31 January 2026, between 10:00 PM and 10:30 PM, Sarwan Sah and three of his associates came on motorcycles, including a Royal Enfield Bullet (number 8224), and passed in front of my house. They were shouting, abusing, and using very dirty and insulting words to provoke and threaten my family. Hearing this, I, my mother, my brother, and other family members came outside to see what was happening. This incident was recorded in the CCTV camera of our neighbour.

After abusing us, Sarwan Sah and three of his associates went a short distance away and waited about 20–30 meters from our house near Dinesh Giri More, clearly with bad intentions. After that, I and my brother, Suraj Kumar Mahato, went near them only to request them to stop abusing and disturbing our family.

Instead of stopping, all the above-named persons, who were already waiting there, suddenly attacked us without any provocation. They had come fully prepared and had gathered there with the clear intention to assault us, forming an unlawful assembly. They beat us mercilessly using knives, sharp blades, iron rods, wooden sticks, and daos, and their actions clearly showed that they intended to kill us. During the attack, my brother and I cried loudly for help, but no neighbour dared to come forward, as they were many in number and were carrying dangerous weapons. Even when our family members and relatives tried to rescue us, they continued the assault and overpowered us, which caused me extreme fear and severe mental trauma. After that, Sarwan Sah, Khushi Sah, and Dipti Sah again attacked me and my brother with knives and other sharp weapons, aiming at vital parts of our bodies, clearly trying to kill us. Due to this brutal attack, both of us suffered serious injuries and fell on the road. During the incident, they also snatched cash amounting to ₹25,000/- from one of my family members.

My sister managed to record part of the incident on her mobile phone, and also captured the incident. Meanwhile, our family members called the police, and when the police vehicle arrived, all of them ran away from the spot. After the incident, our family members took me and my brother to Siliguri Hospital, where we received medical treatment. Our medical reports are available.

At present, I and my family members are very scared, as these persons are dangerous and may attack us again or even kill us. All these acts are serious criminal offences. I am ready to cooperate with the police and to provide medical papers, photographs of injuries, CCTV footage, and mobile video recordings.

I respectfully request you to register this complain, take strict and immediate action against all the persons involved, protect me and my family.
