In producing herewith following four arrested persons namely Prem Ray (32 years) S/P Lt Ramesh Ray of Jyotinagar near Gas Godown, ward no 41, PS Bhaktinagar, Dist Jalpaiguri. 2) Joy Mondal (19 years) S/O Sanjay Mondal of Hossainpur, PO Kathabari, PS Gangarampur, Dist Dakshin Dinajpur. A/P Jyotinagar near Bidhyasagar club under Bhaktinagar PS. 3) Dipankar Roy @ Gusthi (27 years) S/O Lt Manu Roy of Bhabasindhu colony, near Radio Centre, PS Bhaktiagar, Dist Jalpaiguri. 4) Ananda Roy (32 years) S/O Atul Roy of Dakshin Ektiasal, near Diamond yuva club, ward no 40, PS Bhaktinagar, Dist Jalpaiguri along with following seized articles viz:

- 1) One yellow colour iron made hammer having weight approx. 500 grams recovered from the exclusive and Conscious possession of Prem Ray.
- 2) One iron made chisel locally known as Chini weighing approx. 250 garms recovered from the exclusive and Conscious possession of Dipankar Roy @ Gusthi.
- 3) One iron made cutter having length approx. 8 inches recovered from the exclusive and Conscious possession of Joy Mondal.
- 4) One iron made wrench having length approx. 8 inches recovered from the exclusive and Conscious possession of Ananda Roy.
- 5) One Black & White Colour Pulsar 200 NS motorcycle having registration no WB 74 AX 5336.

I, SI Youel lepcha S/O Jai Tshering Lepcha of Bhaktinagar PS, Siliguri Police Commissionerate do hereby lodge this complaint against the above noted persons and 7/8 others to the effect that on 02.02.2026 at 00:30 hrs received a specific source information that 11/12 miscreants have assembled at PC Mittal Bus Terminus under Bhaktinagar PS, with deadly weapons and making preparation for committing dacoity to the passerby area. Accordingly I informed the matter to the I/C, Bhaktinagar PS and diarized the fact in General diary vide Bhaktinagar PS GDE No.66/26 dated 02.02.2026 and as per order I along with ASI Khagen Barman, ASI ASI Dlpak Karmakar and C/374 Debraj Biswas all of Bhaktinagar PS, SPC, left for PC Mittal Bus Terminus under Bhaktinagar PS to work out the information in hand vide GDE No-67 dated 02.02.2026.

At about 00.50 hrs we arrived at the at PC Mittal Bus Terminus as indicated by the source we noticed that 11/12 persons assembled there and they were whispering in a very low voice. Accordingly, we cordoned the place properly and very carefully and approach towards them very slowly and carefully but seeing the police party they started shouting police and started to flee away from the spot but we the police party after somehow managed to apprehended above noted 04 (four) of them with deadly weapons in their possession and recovered one black & white colour Pulsar 200 NS motorcycle having registration no WB 74 AX 5336 but 8/9 persons managed to fled

away from the spot taking the advantage of darkness and open place. On being asked the apprehended accused persons disclosed their name and identity as noted above. During interrogation they stated that they were present there and making preparation for committing dacoity to the passerby area. On search the above noted weapon of offence recovered from their exclusive and conscious possession.

On further interrogation they give different statement in different time and failed to give any satisfactory reply for their presence with deadly weapons in the middle of the night.

Accordingly, I seized the above noted weapon of offence from their exclusive and conscious possession under proper seizure list in presence of witnesses duly acknowledged by the accused persons and subsequently, arrested them under proper memo of arrest also informed them about ground of arrest in writing and observing all the formalities of arrest the whole search seizure was made on 02.02.2026 in between 01.05hrs to 01.45 hrs the whole seizure was conducted under proper audio video record.

Under the above noted fact and circumstance, I, therefore pray to you that a specific case under proper section of law may kindly be started against the arrested persons viz. 1) Prem Ray (32 years) S/P Lt Ramesh Ray of Jyotinagar near Gas Godown, ward no 41, PS Bhaktinagar, Dist Jalpaiguri. 2) Joy Mondal (19 years) S/O Sanjay Mondal of Hossainpur, PO Kathabari, PS Gangarampur, Dist Dakshin Dinajpur. A/P Jyotinagar near Bidhyasagar club under Bhaktinagar PS. 3) Dipankar Roy @ Gusthi (27 years) S/O Lt Manu Roy of Bhabasindhu colony, near Radio Centre, PS Bhaktinagar, Dist Jalpaiguri. 4) Ananda Roy (32 years) S/O Atul Roy of Dakshin Ektiasal, near Diamond yuva club, ward no 40, PS Bhaktinagar, Dist Jalpaiguri and others also arrange for its investigation.
