I Thumba Tamang, s/o Pradip Tamang, presently residing and working at Mahananda Barrage Circle, Teesta Barrage Project as an LDC would like to state you that on 31/01/2026 we had Departmental Picnic at Toribari, Salugana and around 5 p.m, After finishing and packing up our picnic in Toribari, I along with my Office Colleague Thendup Shepa my Senior Assistant Engineer (Sr) Lakpa Tenging Shepa got into Sir's Govt Vehicle. Initially I asked him to drop me at Rajceling More but my Sir' Lakpa Tenging Shepa (AE) insisted to come along with me to meet my friend Chusang Tamang (Yonzon) at Salbari. After meeting my friend we decided to go to Baranda Restaurant where we sat down and drank some Beers together. After some initial conversations, My Sir' Lakpa Tenging Shepa Misbehaving and insulting my friend Chusang Tamang and also using abusive language about my friends mother and his Designation. After some heated arguments the owner of the Restaurant asked us to leave the Restaurant immediately. After which I asked him to leave and I personally went to see him off to his vehicle when he also humiliated me before leaving.

After some time around 10.50 pm, He came back with his Brother, Dawa Norbu Shepa (SI of police) along with his unknown friend and his Driver Abhiraj Roy, who then charged me directly when I confronted them, His Brother (Dawa Norbu Shepa) and his friend started assaulting me and in my self-Defence I also fought back while my friend Chusang Tamang tried to separate us. After which my friend Chusang Tamang dragged me to some place and took me home.

Next morning, I was in severe pain in my whole body, and had swellings in my head, forehead and my face and also my left hand. Hence I also went to the Doctor for my medical checkup at Siliguri District Hospital where I found I had no such major injuries in my hand. But I still have Head swelling and Body pain and I still feel dizzy.
