namely - (i) Divya Chhetri, owner of the restaurant
(ii) Ayush Tamang (iii) Abhishek (iv) Suraj Singh
and (v) Nayan Paliyar.

Sir, With due respect and humble submission, I,
Sahel Subba, s/o - Subash Subba, Ujjwal Nagar, Himmat,
Matigara would like to inform you that on 31st
Feb, 2026 at around 11:15 pm - 11:30 pm, when me
and my brother Akash Rai, s/o - Anil Rai, Teesta Valley
Tea Garden, Rangli Rangliot, Darjeeling were walking
on the street from Sukna to S.I.T since we
didnot get any vehicle (Rapid, Auto, Tolo, etc), out
of the blue, two people who were on the terrace
of Grace Homestay started hurling abuses at us
and started to threaten us. Then, all of a sudden
they started to descend downstairs from the building
of Grace Homestay and Pachheri Restaurant. A group
of 5-6 people came towards us and started to
assault us. They were continuously throwing
punches at us, hurling abuses and even hitting
us. This situation escalated so quickly that
we were in a complete state of shock and
we were unable to process anything.

In order to calm down the situation,
I even told them that my father is also in
the police force but they didnot stop. The homestay
and the restaurant also have CCTV cameras

which might have captured the whole incident.
It is also noteworthy to mention that these people
might have been under some type of intoxication
that led to this.

I would like to file a complaint against
all the people as mentioned in the subject above.
I would be highly obliged if you kindly lodge
an FIR and look into the matter so that such
incidents may be avoided in the future and
other people would not suffer like us. I am
begging you to take the matter into consideration.
