Subject: Complaint regarding sexual assault and physical assault

Respected Sir,

I, Pushpa Lama, aged 32 years, D/O Late Saran Lama, R/O Sukna Part I, P.O Sukna, P.S Kurseong, Dist. Darjeeling wish to lodge a formal complaint regarding the grave incident that occurred on 31/01/2026 around 11.30 pm evening, on 01/02/2026 as well as on 02/02/2026 outside my restaurant as well as within the restaurant premises named Pachheuri Restaurant located above Ballu Car Wash near SIT, P.S Pradhan Nagar, Dist Darjeeling.

I run a restaurant named Pachheuri Restaurant located above Ballu Car Wash near SIT, P.S Pradhan Nagar. On 31/01/2026 two drunk men walked pass my restaurant one of which named Sahil Subba (mobile no.96792-12916) verbally abused my restaurant staffs named Avishek Bhengra, Suraj Oraon & Ayush Tamang with language calling them "Randi ko chora" translated to "son of a whore". After hearing such abusive and filthy language spoken, all my above-mentioned staffs walked towards them and asked why they used such filthy language. Upon such questions asked by the staffs, Sahil Subba threatened all my staff members "Ma Polibe ho, mero bau Police ho, ma toh harulai chordina", "sala randi ko chora haru" translated to "I'm Police, my father is Police, I'll not spare any one" "Bastard, sons of whore". After this abusive verbal assault, these two intoxicated men became more violent and started to physically hit the staffs of my restaurant by choking the neck of Ayush Tamang and punching all of them in front of my restaurant, due to which my staffs had no resort but in self-defence hit back at the miscreants. In this violent act by those two men, me and my business partner Diwas Chettri intervened to calm the two men when Sahil Lama physically punched me in my Breasts in the violence. Subba

That again the next day on 01/02/2026 around 1.30 pm these two men accompanied by 3 more other men came to my restaurant premises. After entering these men verbally assaulted me and called me "Randi" and told me that we will face bad consequences.'

That on 02/02/2026 around 3.30 pm the same two individuals along with some police personnel in police van in uniform came to my restaurant out of which one being Sahil Subba started to record video the restaurant alleging to be the victim and verbally charged me and my restaurant staffs.

That all the incidents have been recorded in my restaurant's CCTV camera.

That due to the continuous verbal, physical assault by these two men and their associates, I have been facing mental trauma due to which I'm not able to lead a peaceful life ever since the incident.

That I have a strong suspicion about the two men one being Sahil Subba will not leave me alone and will continue to harass me, due to the safety of my restaurant staffs, business partner and safety of myself lies in Jeopardy.

That the entire incident has caused me fear and confusion due to which me and my business partner have not been able to run our business and due to such reasons I was not able to come to the police station immediately.

Therefore, I humbly request your good office to kindly register my complaint as an FIR; Initiate a thorough investigation into the matter, take necessary legal action against all persons involved including those for sexual assault and physical assault

I am ready and willing to co-operate fully with the investigation as and when required.
