Sir,

In producing herewith one (01) accused person namely Nikhil Kumar (22 yrs) S/O Indal Sah of Vill- Kharampur, PO+PS- Kathara, Dist. - Baisali, Bihar under arrest along with the following seized articles viz :-

- (i) One (01) blue colour bag styled as "AMERICAN TOURISTER-24" containing one packet wrapped with red colour cello tape containing 8.749 Kgs of Ganja - Marked as Exhibit-"A".
- (ii) One (01) blue colour bag styled as "UNIVERSAL" containing one packet wrapped with red colour cello tape containing 8.155 Kgs of Ganja - Marked as Exhibit-"B".
- (iii) One (01) grey colour bag styled as "UNIVERSAL" containing one brown colour packet containing 5.216 Kgs of Ganja - Marked as Exhibit-"C".

I, SI Abu Taleb S/O Late Abdul Latif of Pradhan Nagar PS, Siliguri Police Commissionerate do hereby lodged this written complaint against the above noted arrested accused person namely Nikhil Kumar (22 yrs) S/O Indal Sah of Vill- Kharampur, PO+PS- Kathara, Dist. - Baisali, Bihar to the effect that on 04.02.26 at 18.55 hrs, I received specific reliable secret source information that one person would be come to Siliguri Junction carrying with huge quantity of Ganja in 02/03 bags. Accordingly, the matter was diarized in PS General Diary vide Pradhan Nagar PS GDE No. 238 dated 04.02.26 and I informed you in writing. Subsequently, being directed by you at about 19.05 hrs myself along with SI Goutam Mallik, SI Bandhan ROY, ASI Prabal Sarkar, ASI Bikash Roy and others force of Pradhan Nagar PS, SPC left for Siliguri Junction under PS Pradhan Nagar, Dist. Darjeeling without any search warrant or authorization for search which could not be possible to obtain from a competent authority for sudden development of such a sensitive information and also for not giving him opportunity for concealment of evidence or facility for his escape. This refers to Pradhan Nagar PS GDE No. 239 dated 04.02.2026 and M.C.C. No. 133/26 dated 04.02.2026. I also informed one Videographer namely Somnath Chatterjee, S/O Sushil Chatterjee of Arabinda Pally, Gokhel Road, Ward No 22, PS- Siliguri, Dist. Darjeeling over Mobile Phone and requested him to come to Siliguri Junction under PS Pradhan Nagar, Dist. Darjeeling with his video camera for the purpose of video graphs if required. On way, I briefed all the Police personnel properly sharing them the nature of information in hand. I also contacted with RT Van officer ASI Julfikar Husain and shared the information and also directed him to come to Siliguri Junction under PS Pradhan Nagar, Dist. Darjeeling to accompany as well as to assist us.

At around 19.20 hrs we arrived at Siliguri Junction and contacted with my source who stated that the person possessing huge quantity of Ganja will come to Siliguri Junction within a short period of time. Then, I requested two available independent persons namely (i) Krishna Dusadh (49 yrs) S/O Late Narayan Dusadh of Rajendra Nagar, Coolipara, Ward No-01, PS- Pradhan Nagar, Dist. Darjeeling and (ii) Suraj Paswan (30 yrs) S/O Gopal Paswan of Rajendra Nagar, Coolipara, Ward No-01, PS- Pradhan Nagar, Dist. Darjeeling to remain present at the spot and act as independent witness if any search and seizure would make which they agreed. I also issued notice to the above mentioned two independent witnesses. In the mean time RT mobile officers ASI Julfikar Hussain along with force came to the spot to assist us. At around 20.25 hrs my source informed me that the person was standing at beside Hill Cart road near of Raj Bus Counter, Siliguri Junction with 03 bags and from a considerable distance he pointed out the suspect. Accordingly, being pointed by the source we cordoned the place from every corner with due care and caution and managed to detain him with 03 (three) bags in his possession. Thereafter, we disclosed our identities as Police personnel (as 4/5 police personnel of our team were in civil dress for our convenience) and informed him regarding the information in hand. On interrogation he disclosed his identity as Nikhil Kumar (22 yrs) S/O Indal Sah of Vill- Kharampur, PO+PS- Kathara, Dist. - Baisali, Bihar.



After prolonged interrogation he admitted his guilt and disclosed that he is carrying approx 22 kgs of Ganja in three bags and he was waiting for a Bihar bound bus. I further informed him that the search of the bags is required to clear the doubts. I accordingly issued notice in writing to him whether he wanted to be searched in presence of an Executive Magistrate or by any Gazetted officer which he agreed to be searched in presence of any of the above noted officer.

Accordingly, I informed the facts to you over mobile phone and requested you to arrange for an Executive Magistrate or Gazetted officer for the purpose of supervise the entire search and seizure process. At around 21.55 hrs the above mentioned camera man namely Somnath Chatterjee, S/O Sushil Chatterjee of Arabinda Pally, Gokhel Road, Ward No 22, PS- Siliguri, Dist. Darjeeling arrived at the spot at in front of Raj Bus Counter, Siliguri Junction with his camera for the purpose of videography. At around 22.05 hrs you arrived at the spot in front of Raj Bus counter, Siliguri Junction under PS- Pradhan Nagar, Dist. Darjeeling and informed me that no Executive Magistrate was available to supervise the process of search and seizure at this time. You further informed me that being a gazetted officer you are legally authorise to give an order to search the bags of the detained person. I further served a notice to you to provide necessary permission to search the bags of the detained person and supervise the entire process of search and seizure, if required. Then, following your direction, on camera, I offered both the independent witnesses and the detained person to search our police team but they denied for searching Police team. Thereafter, in your presence and in presence of the independent witnesses, all the three bags of said detained person were opened and total three packets of Ganja was recovered from three bags. On demand the above named detained person failed to produce any valid document/paper for possessing or selling such huge quantities of Ganja (Narcotic Substance). On further grilling, he confessed his guilt and stated that he procured the said quantities of Ganja clandestinely from Cooch Behar for the purpose of selling the same in high rates to his designed customers in Bihar for his wrongful gain and also stated that he was engaged in such type of illegal business for the last few months for his wrongful gain within a short period of time.

Accordingly, as per your order I seized the following articles viz:- (i) One (01) blue colour bag styled as "AMERICAN TOURISTER-24" containing one packet wrapped with red colour cello tape containing 8.749 Kgs of Ganja - Marked as Exhibit-"A", (ii) One (01) blue colour bag styled as "UNIVERSAL" containing one packet wrapped with red colour cello tape containing 8.155 Kgs of Ganja - Marked as Exhibit-"B" and (iii) One (01) grey colour bag styled as "UNIVERSAL" containing one brown colour packet containing 5.216 Kgs of Ganja - Marked as Exhibit-"C" from the possession of the accused person- Nikhil Kumar (22 yrs) S/O Indal Sah of Vill- Kharampur, PO+PS- Kathara, Dist. - Baisali, Bihar under proper seizure list from the spot in presence of you and independent witnesses and obtained their signature which was acknowledged by the accused person. Subsequently, I sealed and labelled the seized contraband articles in presence of you and independent witnesses at the spot. The whole process of search, seizure and labelling were made under the coverage of video graph executed by the videographer namely Somnath Chatterjee, S/O Sushil Chatterjee of Arabinda Pally, Gokhel Road, Ward No. 22, PS. Siliguri, Dist.- Darjeeling in between 22.20 hrs to 23.15 hrs on 04.02.26 following the provisions of BNSS.

From the above noted facts and seizure of incriminating articles, it is quite evident that the accused person namely Nikhil Kumar (22 yrs) S/O Indal Sah of Vill- Kharampur, PO+PS- Kathara, Dist. - Baisali, Bihar was involved in procuring and selling Ganja illegally contravening the provisions of NDPS Act. Then, I arrested him after observing all formalities, informing him regarding the ground of arrest and issuing a copy of Memo of Arrest and ground of arrest. His maternal uncle, Ajit Kumar, was informed over telephone having Mobile No 8102651138 regarding the arrest of Nikhil Kumar (22 yrs) S/O Indal Sah of Vill- Kharampur, PO+PS- Kathara, Dist. - Baisali, Bihar, as provided by the accused.

Under the above facts and circumstances, I pray before you that a specific case under proper sections of law may kindly be started against the accused person namely Nikhil Kumar (22 yrs) S/O Indal Sah of Vill- Kharampur, PO+PS- Kathara, Dist. - Baisali, Bihar and its investigation may kindly be arranged.
