F.I.R

Sub: Complaint against Debasish Bhattacharya, Kajal Biswasharma and 01 other.

I, Raaj Malhotra, S/o Ravindra Malhotra, presently residing at Ekka House, Ground Floor, Chayanpara, Zilla Parishad Road near Dumping Ground, P.S. Bhaktinagar, District Jalpaiguri, would like to lodge a complaint against Debasish Bhattacharya, C/o Sisir Kr Bhattacharya, Old Gramain Bank Road, Jaketown near sunrise club Siliguri (M Corp), P.S: New Jalpaiguri, PIN :734007 West Bengal. Kajal Biswasharma and 01 other. Both Debasish Bhattacharya and kajal Biswasharma are employees of Indian railways, Department: TLAC ELECTRICALS, Office Address: NIP CARRIAGE WAGON DEPOT. Post of Debasish bhattacharya is senior section engineer.

It is to mention here that on 10/01/26 I underwent an operation at Basu Clinic for Perianal Abscess and was in rest at my sister's house located at Subash Pally, Ward No. 20, Old Basu Clinic House.

That on 22/01/26 at about 8:30 hrs morning, the above mentioned Debasish Bhattacharya, Kajal Biswasharma and 01 other reached the house of Dinesh Rajak at Bagdogra and started beating him with fist and blows and even threatened to kill him in front of his wife.

After that the 03 (three) above mentioned persons forcefully abducted Dinesh Rajak in their car (Wagon-R), colour brownish, and reached at my sister's place at Subash Pally, where I was in rest after my operation. The above mentioned 3 persons [Debasish Bhattacharya, kajal Biswasharma and 1 other] Forcefully entered my sister's house and projected to be a police officer and started threatening me and my sister saying that they will put us in a false ganja case.

I asked them to sit and talk peacefully. Then it was known that Dinesh Rajak and Dhananjay Choudhury had taken a loan of ₹2,50,000/-. Agreement copy attached herewith. It was also discussed that an amount of ₹1,52,000/- were already transferred in his account from time to time. Documents attached. The remaining ₹1,00,000/- will also be paid in due course.

After hearing this, Debasish Bhattacharya, Kajal Biswasharma and 01 other started assaulting me. Suddenly Debasish Bhattacharya took out a hammer and attacked me with an intention to kill me and as I flipped, the hammer hit my side stomach and thereby I started having pain in my stomach.

After seeing this deadly assault, my sister stopped them and transferred me ₹50,000/- immediately.

They were constantly threatening us by projecting themselves as Police, RPF and BJP party workers and even gave an ultimatum to kill me.

And in a state of fear, on their demand, I transferred an amount of ₹50,000/- (Rupees Fifty Thousand only) via Google Pay. Transaction copy is attached herewith.

Due to their assault, I was in constant stomach pain and in the evening of 22/01/26, I got myself admitted in Basu Clinic and thereafter I was referred to Maharaja Agrasen Hospital, Fulbari, Siliguri, where I underwent treatment for 07 days and was discharged from the hospital on 29/01/26.

After discharge, I was very weak and could not lodge the complaint immediately.

I am in a state of constant fear as Debasish Bhattacharya has been threatening me over phone. Subsequently, he has been constantly threatening Dinesh Rajak and Dhananjay Choudhury over phone and telling them that he will abduct me someday and kill me.

Under this circumstance, I can think of no other alternative but to take the help of law. Therefore, for the safety of my family members and myself, my FIR may kindly be lodged and proper action be taken against the above mentioned 03 (three) persons.
